Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. 4. On 09/24/16, applicant was cited for Sale of Cigarettes to Minor/Underage at 406 W Center Street.

5. On 08/11/18 at 10:15am a 17 year old working in conjunction with the Milwaukee Police Department and WI WINS Tobacco initiative, was able to purchase a 2 pack of Black and Mild Cigars at 406 W. Center Street, The sales clerk admitted to selling the item, but stated he only looked at the birth year on the drivers license. The station was mailed a MARTS enrollment packet.

- 6. On 12/27/19 at 6:21pm, Milwaukee Police conducted a license premise check at 406 W. Center Street. While inside the establishment, officers could smell, and see, cigarette smoke inside and observed cigarette ashes in a potato chip box next to products that were for sale. The station has four electronic slot machines that patrons smoke at while playing which was observed by officers while they were watching earlier security footage. Officers also found marijuana, packaged in small baggies for individual sale, inside a jacket that was left abandoned by the slot machines.
- 7. On 12/23/19 at 6:18pm, Milwaukee Police were dispatched to 406 W. Center Street for a subject with gun complaint. The complaint stated that there were a bunch of subjects at that location and one of them was waving a gun and other subjects were selling drugs and were located by the slot machines. No firearm was located.

8. On 01/21/20 at 12:21pm, Milwaukee Police along with Special Agent Georgeann KING of Wisconsin Alcohol & Tobacco, and Special Enforcement Inspector Lori GALLUP, conducted a compliance investigation at the location of 406 W. Center St. The investigation was regarding drug complaints, customers smoking in the location, and loitering panhandling issues. The business agent, Rana ANWAR was at the location during the investigation. Officers contributed the main factor to the complaints, being 4 electronic gambling machines in the lobby of the gas station. Officers located cigarette butts on the floor, throughout the gas station. Also there was a significant amount of cigarette butts, and ash near the gambling machines. Agent KING located several tobacco products in the gas station's inventory that were not properly purchased. Inspector GALLUP addressed the expired occupancy permit, issued an order for the public restroom to be repaired, and then reopened. Investigators found a currency disbursement receipt from one of the gambling machines. Agent KING did order the agent to remove the gambling machine under Wisconsin Statues after it was determined that the machines were not being used for novelty entertainment purposes. Officers informed the business agent that subjects are loitering in the lobby, playing the machines and using that as

- a cover to sell drugs. The agent was cooperative and stated the machines are owned and controlled by ATS Novelties LLC, and will consider removing them.
- 9. On 02/17/20 at 12:35 pm Milwaukee Police conducted a license premise check at 406 W. Center Street. Officers observed four gambling machines in the front lobby part of the gas station. Officers spoke with the cashier on scene who stated that the gas station pays out on the machines and showed officers receipts from the machines. Officers looked over the current licenses of the gas station and discovered an entertainment license was not issued by the city, regarding the gambling machines. The agent Rana ANWAR was notified regarding the violations and issued citations.
- 10. On 02/28/20 at 10:20pm Milwaukee Police conducted a license premise check at 406 W. Center Street. Officers observed two subjects operating two of the four gambling machines in the front lobby. The subjects were instructed by officer to stop using the machines, and to leave the gas station, which they complied. Officers continued with the premise check and located near a rack of chips a clear Tupperware container with numerous multicolored pills. Officers suspected the pills to be ecstasy and the pills were later tested positive for Methamphetamine. Officers were informed that the gas station has had previous complaints of subjects selling drugs, and smoking in the store. The suspects would use the gambling machines to be at the location and conceal contraband with in the chip racks. Officers were allowed to review video and observed the two subjects being in the store for over a hour playing the gambling machines. Officers had knowledge from a license committee on 02/19/19 that the gambling machines were not to operated, and a violation of the business plan. The gambling machines could not be operated without an entertainment license through the city. It was confirmed through the online licensing system that a PEP license was not located or applied for. Officers order the clerk to shut down the machines, which he complied. The agent was later contacted and issued a citation regarding the gambling machines.
- 11. On 03/05/20 at 11:52pm Milwaukee Police conducted a canvass at 406 W. Center St, regarding a shots fired complaint at 2719 N. Vel R. Phillips St. Officers spoke with the gas station clerk who stated that he did not see or hear anything regarding the incident. The clerk allowed officers to review video surveillance. Officers discovered that the incident occurred in the parking lot of the gas station. The video revealed the victim's vehicle parked near two gas pumps. The suspect exits his vehicle and conducts a hand to hand transaction with the victim. The suspect vehicle then moves towards the east entrance, stops the vehicle, suspects then exits his vehicle to open the truck. The victim exits his vehicle then approaches the suspect and begins to fight with the suspect outside the vehicle. The victim's vehicle then moves to the front of the suspect vehicle by a female driver. The female drivers exits the victim's vehicle and talks to the suspect and victim fighting. Both parties then get in their vehicles. From his vehicle the suspect fires three gun shots at the victim's auto. The suspect auto then exits west bound from the location. The victim sustained a single gunshot to his stomach.
- 12. On 07/27/20 at approximately 8:17am Milwaukee Police checked at 406 W. Center St for a scene regarding a shooting complaint. The gas station clerk allowed officers to review video surveillance. From Camera # 3 officers observed the suspect, and the suspect vehicle a tan/beige 2000's Dodge Caravan with no plates. From the camera footage officers observed the victim pull into the gas station in his vehicle, and begin to pump gas. A short time later the suspect vehicle moves towards the victim, and the suspect exits the passenger side of the suspect vehicle. The suspect and the victim engage in a conversation outside near the victim's vehicle. The victim is then seen hobbling away from the location eastbound. The suspect then goes through the victim's vehicle before returning to his vehicle. The suspect then leaves the location in the suspect auto with an unknown driver. The victim returns to his vehicle and

leaves the gas station driving southbound. Officers recovered one spent casing near the gas pumps.

13. On 12/19/20 at 9:56pm Milwaukee Police conducted a license premise check at 406 W. Center St. Officers observed four gambling machines along the east wall of the gas station. Officers spoke with the gas station clerk who stated that the machines have not been in use and had them unplugged. The clerk was asked by officers why the machines were still in the store if they were not in use, the clerk did not have an answer regarding. Officers did observe an amusement license on the gambling machines expired May of 2020. Officers did not observe or locate an entrainment license with the city for the machines. Officers contacted the agent regarding the license check, and confirmed that no application or license was in LIRA.

14. On 03/11/2021 at 3:26pm officers conducted a license premise check at BP gas station at 406 W. Center St. The officers spoke with the clerk about a standing trespassing complaint. The employee signed the form and he was provided with signs to post at the business.

15. On 03/24/2021 at 10:23pm officers conducted a license premise check at BP gas station at 406 W. Center St. The officer spoke with the manager, who stated he supports the standing no loitering complaint and welcomes additional police presence.

16. On 08/12/22 at 3:47p.m., Milwaukee Police were dispatched to a Shooting at 406 W. Center St. Investigation revealed two suspects approached the victim, who was parked at a pump, and discharged a firearm striking the victim and their vehicle. The officers recovered three casings in the lot. The employee was cooperative and allowed officers to view video surveillance of the incident.

17. On 10/31/22 at 5:49p.m., Milwaukee Police were dispatched to a Subject with Gun at 406 W. Center St. Investigation revealed the victim and suspect standing outside, exchanging words. The victim then goes inside, behind the glass partition. The suspect is seen tucking an object into their waistband and following the victim in the store, pounding on the glass, demanding money owed to them. The clerk stated the suspect displayed a firearm, so they called the police. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

- 18. On 04/11/23 at 10:30p.m., Milwaukee Police conducted a License Premise Check at 406 W. Center St. On arrival officers observed several people that are known to the officers as panhandlers, loitering around the building. Officers spoke to the employee who stated they have three no loitering signs posted and does not want them loitering. The employee stated when the police come the subjects leave briefly, however, return soon after. There were no violations and cameras were working and functional.
- 19. On 06/14/23 at 2:16a.m., Milwaukee Police were dispatched to a Shoplifting at 406 W. Center St. Investigation revealed a subject entered the store and began throwing items on the counter and the floor, however, did not take anything. The subject was no longer on scene and the employee was cooperative with the police.

- 20. On 06/21/23 at 1:23a.m., Milwaukee Police were dispatched to a Subject with Weapon at 406 W. Center St. Investigation revealed a subject entered the store and attempted to conceal items, however, the cashier confronted the subject. The cashier then locked the subject in the store, at which time the subject became agitated and began to throw items around, also taking a shovel and breaking a mounted plasma tv. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
- 21. On 06/28/23 at 7:35a.m., Milwaukee Police were dispatched to a Threat at 406 W. Center. Investigation revealed a subject entered the store and began to throw things around, made threats to the employee, then took pictures of the employee's vehicle. The subject was no longer on scene, and the employee was very cooperative with the investigation and allowed officers to view video surveillance of the incident.
- 22. On 06/29/23 at 12:20a.m., Milwaukee Police were dispatched to a Battery at 406 W. Center St. On arrival officers attempted to interview the victim who was naked and bleeding from their face and head, however, the victim refused to speak to officers. The employee stated the victim walked into the business, naked and requested police services. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident, however, it did not capture the entire incident as it took place on the street.
- 23.On 07/07/23 at 12:17a.m., Milwaukee Police were dispatched to a Shots Fired at 406 W. Center. Investigation revealed an employee's unoccupied vehicle was struck by gunfire, while parked in the parking lot. The employee stated they heard the gunfire, however, only saw the muzzle and did not get a description of the vehicle or subject(s).
- 24. On 07/12/23 at 3:24p.m., Milwaukee Police were flagged down by a citizen who stated they were assaulted at 406 W. Center St. The citizen stated they were inside the gas station, when they were accused of shoplifting. The citizen denied taking anything and stated the items they had were from another store. The citizen stated the employee then locked them inside and a security guard proceeded to strike them, causing them to bleed from the nose. Officers conducted follow up and spoke to the employee who stated the citizen is a known shoplifter, they have called the police on in the past. The employee admitted to locking the citizen in, however, denied a security guard being onsite and stated it was a frequent customer that got into a physical fight with the citizen. The officer attempted to view video surveillance of the incident, however, it was two days later, and were told the video did not go back to the incident date.
- 25. On 07/29/23 at 12:05p.m., Milwaukee Police conducted a License Premise Check at 406 W. Center St. This was in regards to a shooting unrelated to the property. A victim of a shooting made statements they work at the gas station and are paid under the table to provide security and clear the location of loitering. The officers interviewed an employee on scene who admitted to knowing the subject, however, denied they were employed in any way. The employee stated the subject loiters there frequently. The employee was advised the subject has been involved in numerous shooting and there exists a chance of incidents occurring there if they continue to allow them to loiter. The employee stated they will not allow the subject to loiter on their property in the future.
- 26.On 09/02/23 at 11:46p.m., Milwaukee Police were dispatched to a Subject with Weapon at 406 W. Center St. Officers interviewed the caller/employee who stated a subject entered and began throwing things around, then left items, without paying. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

- 27. On 09/11/23 at 12:12a.m., Milwaukee Police were dispatched to a Shots Fired in which multiple casings were recovered in front of 406 W. Center. Officers further observed a window to the gas station had been struck by gunfire. The officers interviewed the employee who stated they observed the window being struck by gunfire and ducked for cover. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
- 28. On 10/14/23 at 10:14p.m., Milwaukee Police were dispatched to a Shooting at 406 W. Center St. The officer interviewed the clerk who stated they heard 2-3 gunshots from the area of the pumps, and a subject exit a vehicle, run across the street, then return to the gas station and collapse on the ground. The clerk stated they did not see the suspect. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident. Video depicts a suspect armed with a handgun, discharge his gun toward the victim, then fled on foot.
- 29. On 11/15/23 at 11:43a.m., Milwaukee Police conducted a License Premise Check at 406 W. Center St. Assisting in this assignment were agents from Wisconsin Department of Revenue Alcohol and Tobacco and DNS. This was due to an anonymous complaint the business was selling single cigarettes. The officers did not find any evidence indicating the sale of single cigarettes, however, the DOR Agent did confiscate several boxes of tobacco products without invoices. The agent admitted via telephone to the Agent, the products were purchased illegally. The officer observed the business sells digital scales and fake tire gauges, which are typically used for narcotic use and sales. The DNS inspector issued a nuisance order due to a garbage violation.
- 30. On 01/02/24 at 9:33p.m., Milwaukee Police were dispatched to a Drug Dealing at 406 W. Center St. Prior to arrival the officers were advised multiple hand to hand drug transactions were taking place from a vehicle in the lot. On arrival officers observed the vehicle parked and conducted a Field Interview of the occupant. Officers detected a strong odor of marijuana emanating from the vehicle as well as a white powdery substance on the center console. An officer viewed video surveillance at the establishment and did observe multiple people walking up to the vehicle, conducting hand to hand transactions. A search incident to arrest revealed a back pack in the trunk of the vehicle containing suspected cocaine; suspected methamphetamine; and a green leafy substance suspected marijuana, as well as three scales. Officers also recovered a firearm with a switch and extended magazine, which was reported stolen.

The officers then conducted a License Premise Check of the establishment and found the store to be organized but messy. The cashier denied seeing the vehicle in the parking lot and stated they only look forward at customers and does not look outside at the pumps. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

This report is written by PO James TERRELL, assigned to District Five Late Power Shift, Squad 5468 with PO Nora BURLO.

On Tuesday, April 11, 2023, at approximately 10:30PM, PO BURLO and I, conducted a license premise check at 406 W Center St (Center St BP Gas Station), which is located in the City and County of Milwaukee.

Upon arrival, I observed a female subject seated in a walker/chair located near the front entrance and another female subject sitting near the east side of the building. I have observed these same subjects, usually along with 5-10 other subjects loitering outside of this premise on a daily basis. I observed these subjects as known drug users who pan handle for money based on my experience as a Milwaukee Police Officer and patrol in the approximate area of this premise.

PO BURLO and I made contact with employee of the location who was identified as Jasvir SINGH (M/W, DOB 10/08/1983) who stated he is an employee at the premise who works daily 9:00AM-9:00PM. SINGH stated he has three District Five no loitering signs posted in the windows and does not want people standing outside of the premise. SINGH stated police will come briefly and the subjects will walk away but as soon as the police drive away the subjects come back. SINGH stated he would like more patrol at the location. SINGH was cooperative in this investigation.

I conducted a walkthrough of the location and did not observe any violations of expired food. I observed the premise to have functional surveillance cameras inside and outside of the location.

This report is written by Police Officer BUKOVSKY assigned to District 5, Late Power Shift.

On 06/21/2023 at 0123hrs, my partner Officer WELCH and I (Squad 5426) were dispatched to the BP Gas Station at 406 W. Center Street for a subject with weapon call. This location is located within the City and County of Milwaukee. We arrived in full duty uniform, marked squad car, and wearing body-worn activated cameras.

We arrived at the listed address at 0125hrs and viewed merchandise all over the stores floor and damage to electronic items. We were met by the store manager and witness; Gurwinder SINGH (WM 12/01/1997) who stated the suspect had just left the store on foot a few seconds prior to our arrival. SINGH stated the suspect was northbound on Vel R Phillips and described him as a black male, black shorts, sandals, and is now shirtless after removing his white tank-top after exiting the gas station.

We immediately saturated the area but did not locate the suspect.

We returned to the listed address and took a statement from SINGH; he stated the male suspect had entered the store and attempted to conceal \$4.00 or merchandise in his shorts. SINGH viewed this and confronted the suspect from behind the merchant's safety glass. The suspect removed the items and stated he would now pay for the items. At this time SINGH had called 911 and locked the entrance door via a security door lock button. The suspect for the next several minutes began trying to force the door open using various items. The suspect became increasingly agitated and began knocking over shelves, throwing items from the counters including electronics. SINGH stated the suspect picked up a shovel from inside the store and broke the plasma TV that was mounted on the ceiling. SINGH then released the security button, and the suspect exited the store without any unpaid merchandise.

Security Cameras:

My partner and I watched the store security cameras, specifically cameras #5 and #11. Using my body cameras to record the incident, we viewed the suspect attempting to conceal merchandise upon entering the store. The suspect became increasingly aggressive in the store once being locked inside with two other customers. The suspect did find a shovel inside the store and used it to damage the mounted television. The shovel was not used as a weapon towards anyone. Suspect used the shovel in a failed attempt to pry open the door to escape. Suspect began knocking over shelves with merchandise on it. Suspect then threw items off the counter including an electronic lottery device machine. Suspect entered the store at 0116hrs and exited at approximately 0124hrs.

Suspect was viewed on camera as a black male, approximately 6'00", 180lbs, medium build, and dark skin. Suspect was wearing a black hat with a blue brim, white tank-top, black shorts, and sandals with white stripes.

Based on the camera surveillance, Squad 5341 was unable to see the whole entire incident. Surveillance did capture what appeared that SARNOWSKI was in the middle of the gas station parking lot and eventually walked east bound towards N Vel R Phillips Ave., where several subjects appear to approach SARNOWSKI in the street and beat him up. Due to the quality of video, it is difficult to see exactly what happens, because it is not all captured on scene. Moments later, SARNOWSKI appears to be dragged onto the sidewalk. During the time of the incident, few vehicles stopped to check on SARNOSKI while lying on the ground as well as multiple people approached SARNOWSKI from a distance then proceeded to leave the scene. Unknown if any actors were involved in the incident.

SINGH stated during the time of incident, SARNOWSKI walked inside the Gas Station naked requesting for police services in which at that point SARNOWSKI had blood all over. Police services were called and officers arrived on scene. SINGH stated he did not observe, SARNOWSKI get injured at all. SINGH was cooperative.

On Wednesday, July 12, 2023, while responding to a 2350 N 6th Street for a Suspicious Person-other call we were flagged down by a citizen at the intersection of N 8th St and W Center St, who stated that he was assaulted at the gas station located at 406 W Center St by an employee of the business.

I observed a W/M who was bleeding from the nose.

The victim, Jake M FINN (M/W, 02-21-92) stated that he'd called for police from his cell phone (262-224-8940) prior to seeing our squad traveling E/B on W Center St. FINN stated that while shopping within the gas station at 406 W Center St, he was accused of stealing from the business. FINN stated that he attempted to let the employees know that the items in his possession were purchased previously from a different location. FINN denied the shoplifting accusation. FINN stated that during a brief dispute between he and the store security guard, he was struck four to five times by the store security guard. FINN stated that the employee then locked the entrance, trapping him inside the business until the merchandise was confiscated by the BP employees. The CAD stated that the initial call came from the store employee, Sabu SINGH. The CAD stated that "THERE IS A MALE SUBJ INSIDE HIS STORE WHO HAS POSSIBLE MENTAL HEALTH ISSUES SHOPLIFTING FROM HIS STORE // THE SUBJ WAS YELLING IN THE BACKGROUND // NFI". FINN requested medical assistance.

Bell Ambulance 419 arrived and assessed FINN. FINN refused further care and was released from the care of Bell Ambulance 419.

I conducted a Follow Up on Friday, July 14, 2023, at 1:14PM. I spoke to the business agent/witness to the incident SINGH, who stated that FINN was observed shop lifting. SINGH stated that FINN frequently steals from the business and provided three PV-17 to separate incidents. SINGH stated that he attempted to contain FINN in the store by locking the magnetic mechanism to the entrance. SINGH stated that FINN then began to swear at him and make threats. SINGH stated that FINN then became verbally abusive to him and another subject within the store. SINGH stated that the subject was not a security guard or employee of the business. SINGH stated that the subject was a frequent patron. SINGH stated that FINN continued the verbal abuse toward the patron who then struck FINN after warning him to stop. SINGH stated that the merchandise was forfeited by FINN who was then released from the business.

On Saturday, July 29th, 2023, at 12:05 PM, I conducted a Business Check at 406 W Center St (BP Gas Station), located within the City and County of Milwaukee.

The purpose of this business check was to discuss statements made by Donnell WHITE (B/M, 4/11/1983), who was the victim of a shooting unrelated to the property. (IR: 232010199):WHITE informed detectives that he had been working at the BP gas station located at 406 W Center Stand and was being paid \$300 a week "under the table" to clear loiterers and panhandlers from the parking lot.

Upon my arrival, I spoke with the only employee on duty at the time. This employee was identified by his Wisconsin Driver's License as Paramjit SINGH (W/M, 5/12/1986). SINGH stated the owner was not on site and that he is the primary employee at the gas station and has worked there full-time for the past five years. I asked SINGH about a subject in a wheelchair (WHITE), and he stated he knew who I was referring to. When I asked SINGH if WHITE was employed by the gas station, SINGH laughed and stated WHITE loiters at the gas station himself and repeatedly and vehemently denied WHITE being paid for any services.

SINGH stated he does not call for police when WHITE loiters at the gas station. The video surveillance footage that officers observed from 406 W. Center St., BP gas station surveillance video footage revealed on 10/14/2023 at approximately 10:13 PM that a black male approximately 6 ft tall, last seen wearing a grey hoodie with the hood up, gray sweatpants, black tennis shoes, armed with a handgun discharged a firearm into the victim's direction striking the victim and was last seen on foot southbound on N. 4th St. SINGH stated his phone number was 414-4055-6944.

ANWAR (I/M, 05/07/1974). I then spoke to Rana G. ANWAR via phone. Rana G. ANWAR stated, who stated he was in fact the manager of the business, and his brother was the owner/business agent. The business agent was identified as Rana F. ANWAR (I/M, 04/15/19880), who was not available to report to the business.

I Officer GARLAND informed SINGH that we received a complaint that the business was selling single

While on scene, Agent Ashley SCHNERING (ATF) discovered that the business had a large amount of tobacco products that did not have invoices. Agent SCHNERING spoke to Rana G. ANWAR, via phone, who willing admitted that he purchased the tobacco products from an individual from Chicago Illinois. Agent SCHNERING seized five boxes of tobacco products as evidence because the items were illegally purchased. Agent SCHNERING provided be a copy of the ATF property receipt (AT-225) and the ATF filed report (AT-129) that I later uploaded to the MPD (Milwaukee Police Department) Evidence.com system.

I observed the business licenses were posted on the wall of the enclosed cash register area and they were up to date. I also observed that the business was selling "Digital Z Scales," and fake tire gauges (Air Pencil). Through my training and experience, digital scales are commonly used to weigh illegal narcotics, and the fake tire gauges are used as to smoke illegal narcotics such as cocaine base (Crack Cocaine).

Inspector Robert LANNIN (DNS) discovered that the business had a building code violation; garbage violation. There was an abundance of trash scattered on the ground near the garbage dumpsters. Inspector LANNIN issued a DNS nuisance order for the business.

This location is a designated nuisance premise. The business has not submitted an abatement plan to eliminate nuisance activity.

Upon officer arrival, PO TERRELL and I observed a white '09 Infiniti G37 (WI Dealer Plate# WH8118K / Vin# JNKCV61F19M361567), parked on the gas station parking lot in front of a gas pump nearest to the gas station entrance, occupied by one B/M subject who was sitting in the driver's seat of the listed

vehicle. PO TERRELL then activated our squad vehicle's emergency lights and audible siren in order to conduct a Field Interview of the Infiniti and it's occupant.

As officers spoke with ANDERSON, PO TERRELL detected the fresh odor of marijuana emanating from inside the vehicle, and he observed a white powder residue in the center console area of the vehicle, which PO TERRELL suspected to be cocaine residue. As officers continued the search of the Infiniti, PO TERRELL removed a large speaker inside the trunk and located a *Glock 22 Gen 4 .40 fully automatic handgun (Gun Tag #105943, SN #XHZ730)* with a "switch" and extended magazine. The firearm was loaded with one unfired .40 GFL cartridge in the chamber, four unfired PAC .40 cartridges, four unfired Blazer .40 cartridges, two unfired JAG .40 cartridges; five unfired WIN .40 cartridges, and one Federal .40 cartridge in the extended magazine.

A records check revealed the firearm was stolen o 12/20/202, Chicago Police Department Agency Case #G22B1682. ANDERSON was intentionally in possession of a stolen firearm.

A records check revealed ANDERSON is a convicted felon in the State of Wisconsin per Milwaukee County Court Case #2013CF003919 and is prohibited from the possession of firearms.

A records check revealed ANDERSON has open case #2022CF000553 for possess firearm-convicted of a felony and possess w/intent-cocaine.

ANDERSON was taken into custody and conveyed to Milwaukee Police Department District Five for processing.

I then conducted a Licensed Premise check of the Gas station-

Upon a walk-through of the interior, the store appeared organized but messy. I observed one clerk working. He provided me with his International Drivers License which identified him as Jasvir SINGH (W/M, 8/10/83). SINGH stated he has worked at the listed location as a cashier for approximately six (6) years and his hours are 9:00 PM tp 9:00 AM. When asked if he observed the White Infiniti and ANDERSON, SINGH stated he saw nothing and made a motion with his hands that he looks forward

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
