5th Aldermanic District

W. Hadley St. – N. 80th St. to N. 86th St. (ST211130104):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (6-7 foot width of tree border area), and grading.

No individuals appearing.

Ald. Bohl states that a postcard survey was in support.

Ald. Bohl moves to approval with late billing. Prevailed 4-0. (Ald. Wade excused)

8th Aldermanic District

S. 24th St. – W. Greenfield Ave. to W. Scott St. (ST21110133):

Asphalt pavement resurfacing, narrow 40 feet to 36 feet, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (0-5 foot width of tree border area), and grading.

Pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (4 foot width of tree border area), grading, and install traffic calming speed hump(s).
