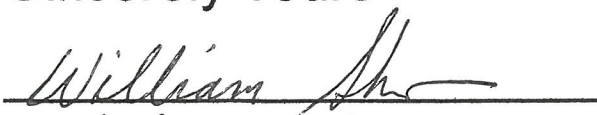
I'm appealing your decision, because Milwaukee County hire,

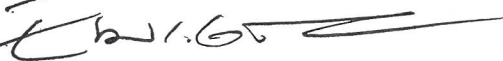
