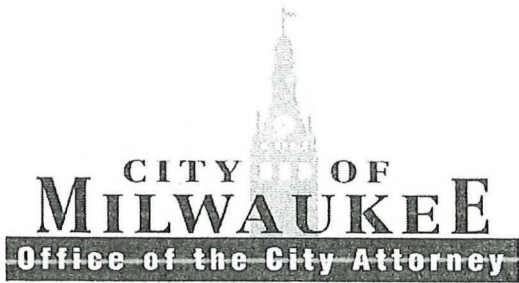

Dear Mr. Washington:

We are in receipt of your claim regarding damages sustained from a collision that occurred on August 26, 2024, at N. 91st Street and W. Silver Spring Drive.

Our investigation reveals that per Wisconsin Police Report#J9L2TCPTR3, on August 26, 2024, you were traveling south on N. 91st Street and made an improper right turn in front of a City sanitation truck and caused damages. It is our view that your actions are the proximate cause of this loss. Accordingly, we are not liable for damages, and we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.
