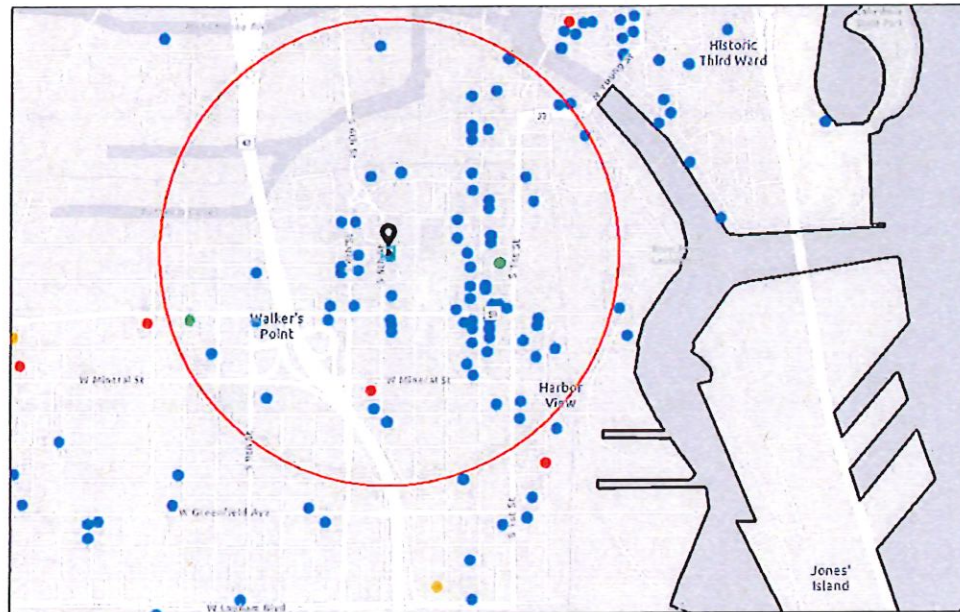


Concentration Map 602 S 5TH ST

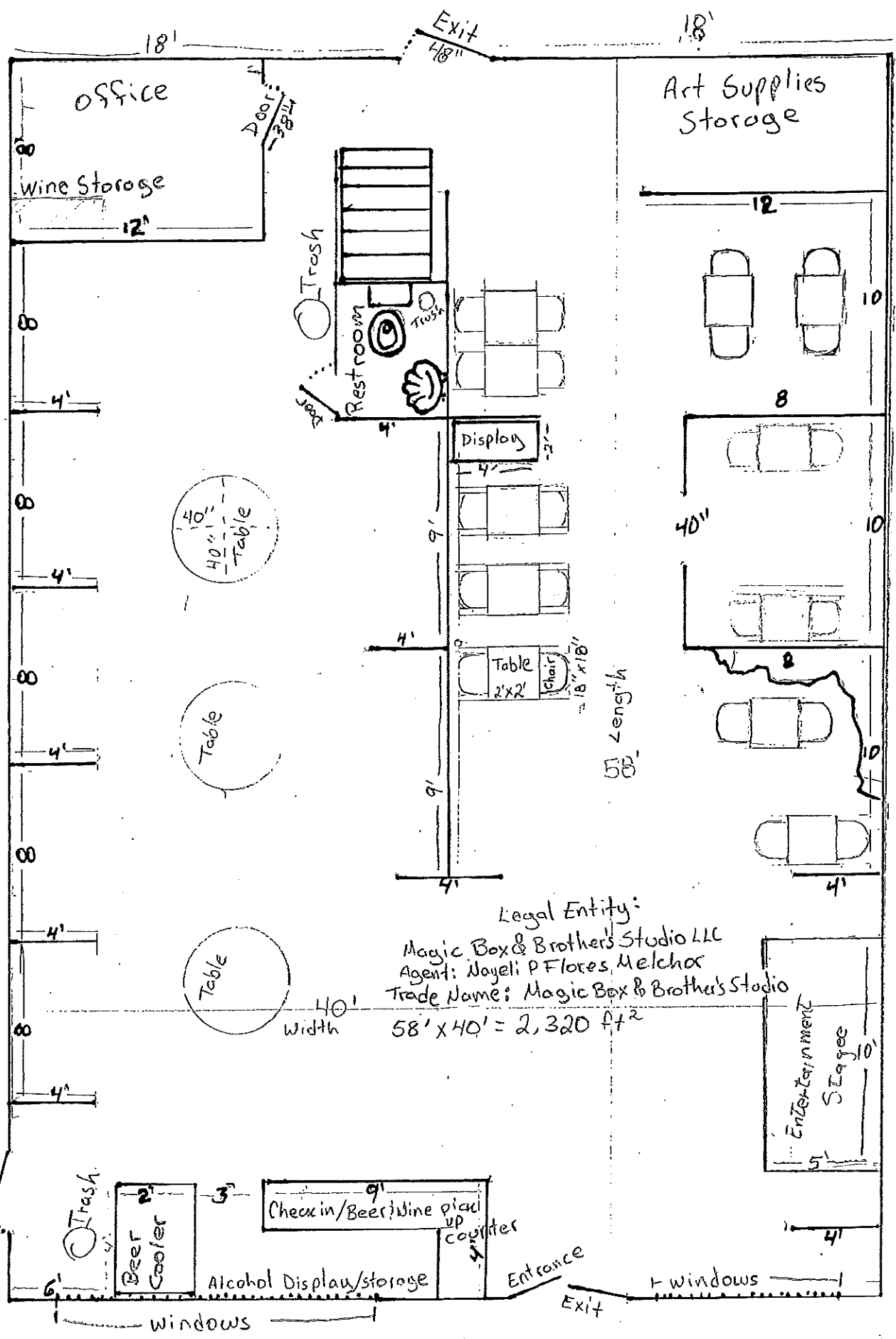

The building is located at the corner of 5th Street and Bruce Street, carrying dual addresses: 600 S 5th St and 602 S 5th St. Its primary entrance faces 5th Street and is accessed through a converted garage door that features two large windows and a double door, giving the entry a modern and welcoming appearance.

Inside, the space measures 40 feet in width and 58 feet in length. A continuous wall runs lengthwise down the middle of the building, dividing the interior into distinct left and right zones while maintaining an open-plan feel.

On the **right side**, which includes the main entrance area, visitors first encounter an open event space. This area is designed to accommodate events such as sip-and-paint gatherings and other cultural or entertainment activities. It offers a flexible, social atmosphere suitable for creative engagement.

Beyond the event space are three themed, interactive rooms, each measuring 10 feet wide by 8 feet long. The rooms are individually styled to reflect a mountain landscape, an outer space experience, and a tropical setting. Each room is outfitted with two tables and two chairs, allowing for small-group activities or immersive experiences.

Running along the central dividing wall on this right side are two distinct art display sections. The first features three tables, each accompanied by two chairs, and includes a decorative display table meant to showcase items such as vases, sculptures, or other visual art pieces. The second section features two tables pushed together to create a larger collaborative surface, surrounded by four chairs, making it suitable for group presentations or discussions.

At the back of the right side, there is a 12-foot by 7-foot storage room equipped with racks for organizing art supplies and materials. An additional emergency exit is located near the middle of the right side, providing accessible egress for safety.

On the **left side**, the space serves primarily as the gallery exhibition area. Just upon entry, guests are greeted by a registration bar that functions as both a check-in station and a point of sale for services or products. The bar is equipped with an FDA-approved beverage cooler and a garbage can, and there's an emergency exit located nearby for quick access.

The main portion of the left side is organized to support art exhibitions. It features five exhibition areas along the left wall, each measuring 8 feet by 4 feet, and two additional exhibition sections along the central dividing wall, each 9 feet by 4 feet. To facilitate social interaction and provide visitors with comfortable browsing breaks, three round standing tables are positioned throughout this section, though no seating is included with these tables.

Toward the rear of the left side, there is a small office space with a wine rack for more storage, and across a gender-neutral restroom and a cleaning area located under the staircase.

Overall, this layout offers a versatile, thoughtfully organized space that balances artistic exhibition, hands-on creativity, and community engagement.

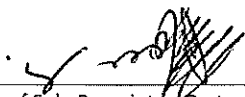

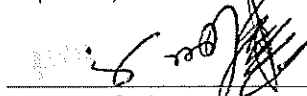
