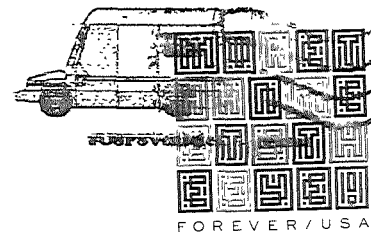

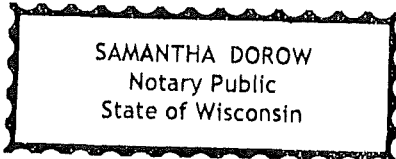

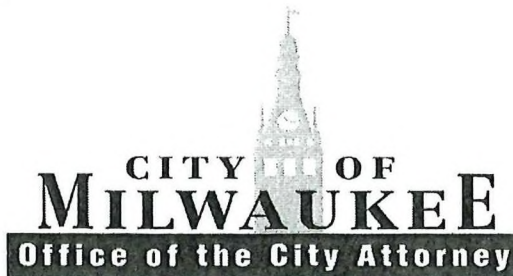

Dear Mr. Pero:

We have received your claim for damages sustained on or about February 12, 2024, allegedly from a city vehicle while your vehicle was parked, at or near 7638 W. Howard Avenue or 7708 W. Howard Avenue.

Our investigation concluded that there is no evidence that damage occurred as a result of a city vehicle. There is no license or vehicle number of a City of Milwaukee vehicle supplied in your claim, that allegedly struck your vehicle and caused damage.

Since there is no evidence that damage occurred as a result of a City vehicle, we cannot accept liability. As such, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.
