Re: Report of the Renewal Application of Saprina Johnson for a Class "B" Tavern license for the premises located at 2979 North 8th Street in the City and County of Milwaukee, Wisconsin ("Champ's Clubhouse").

FINDINGS OF FACT

1. Saprina Johnson (hereinafter the "Licensee") holds a Class "B" Tavern license for the premises at 2979 North 8th Street in the City and County of Milwaukee, Wisconsin ("Champ's Clubhouse"). Said license expired at midnight, November 30, 2007.
2. An application to renew said license was filed with the Office of the City Clerk on October 7, 2010.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. There was a Milwaukee Police Department report dated October 8, 2010, which could form the basis for non-renewal or suspension of the license. There were also written neighborhood objections including allegations of littering, loud music and noise, parking and traffic problems, criminal activity, shots fired and shootings.
4. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, on October 26, 2010 and November 22, 2010, the City Clerk's

Office provided timely notice of the police report and neighborhood objections to the Licensee. A copy of the police report was included with the notices. The matter was scheduled for a hearing on the police report and neighborhood objections on November 9, 2010, and December 7, 2010 in Room 301B of the third floor of City Hall. At those dates, times and place, the Licensee appeared and was represented by Attorney James Toran.

5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On September 24, 2009 at 2:24 a.m. the Milwaukee Police Department responded to a shots fired complaint at 2979 North 8th Street. Officers found no evidence of shots being fired in or outside of the tavern. Police spoke to the bartender Jermenna Lettrell who stated she observed a physical altercation between two female patrons but that security removed them without further incident. Lettrell further stated that shortly after she heard 2-3 gun shots that came from outside the building.
 - B. On June 16, 2010 at 12:30 a.m. officers of the Milwaukee Police Department conducted a license premise check at 2979 North 8th Street. Officers spoke with the bartender Nate Beavers and requested to see his bartender's license. Beavers stated he did not have one and officers observed no other bartender or manager on scene. Police observed a DJ selecting music from an Ipod, which was playing to the crowd, but the tavern did not possess a pre-recorded music license. Officers also recovered a bag of suspected crack cocaine that was found on the floor near the pool table. It was later tested and found positive to be crack cocaine, which was placed on police inventory. Beavers was cited for Class "D" operator's liquor license and the licensee, Saprina Johnson, was cited for responsible person on premise required and pre-recorded music machine license required.
 - C. On July 28, 2010 at 12:27 a.m. officers of the Milwaukee Police Department were dispatched to 8th and Chambers for a fight complaint. Officers spoke to the victim who stated she was at Champs bar and got into an argument with her child's father. The argument turned physical and security broke it up. Police spoke to the security guard

Luther Mitchell who was posted outside of the bar at the time of the fight. Mitchell stated he was told there was a fight inside and once in observed two patrons pulling each other's hair. Officers cited both parties for disorderly conduct.

- D. There were also neighbors who testified in opposition to the license. The committee finds that the neighborhood testimony of chronic episodes of disturbances, excessive noise, disorderly conduct, and gun fire associated with the licensed premise and its patrons to be true. Specifically, the committee finds that a neighbor's documentation of loud disturbances, gun fire, traffic problems and disorderly conduct on March 21, 2010, May 19, 2010, June 24, 2010, July 24, 2010, July 31, 2010, August 8, 2010, October 22, 2010, October 29, 2010 and November 6, 2010 to be true.**
- E. The committee finds that the license applicant's participation in a November, 2010 neighborhood meeting, subsequent plan of action proposed by the licensee, and amendment to the licensed premise's plan of operation, demonstrates the licensee's good faith attempt to address the concerns of neighbors and will benefit public safety.**


CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based upon the above facts found, the Committee concludes that the licensee, Saprina Johnson for the licensed premises at 2979 North 8th Street ("Champ's Clubhouse") has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of her Class "B" Tavern license for the premises located at 2979 North 8th Street in the City and County of Milwaukee, Wisconsin ("Champ's Clubhouse") without undergoing a twenty (20) day suspension of said license. The Committee finds the police report and neighborhood objections to be true. Alderwoman Coggs made the motion for the 20-day suspension and also stated that if no plan of action is delivered to neighbors by the license applicant before the Common Council meeting of December 21, 2010, she will move to reopen the matter and move for denial of the license.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern license of Saprina Johnson for this premises located at 2979 North 8th Street in the City and County of Milwaukee, Wisconsin ("Champ's Clubhouse") with a twenty (20) day suspension of said license.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes, one (1) noe, and one (1) excused recommends that the Class "B" Tavern license held by Saprina Johnson for the premises located at 2979 North 8th Street in the City and County of Milwaukee, Wisconsin ("Champ's Clubhouse") be renewed with a twenty (20) day suspension.



Re: Report of the Renewal Application of Christina M. Elliott, Agent for Competitive Ventures, LLC for a Class "B" Tavern, Tavern Dance and Video Game Center license for the premises located at 4014-24 South Howell Avenue in the City and County of Milwaukee, Wisconsin ("Jerseys Sports Pub & Grill").

FINDINGS OF FACT

1. Christina M. Elliott, Agent for Competitive Ventures, LLC holds a Class "B" Tavern, Tavern Dance and Video Game Center license for the premises located at 4014-24 South Howell Avenue in the City and County of Milwaukee, Wisconsin ("Jerseys Sports Pub & Grill"). Said license expires at midnight, December 15, 2010.
2. An application to renew said license was filed late with the Office of the City Clerk on October 30, 2010.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. There was a Milwaukee Police Department report dated November 5, 2010. There was notice from the License Division that the applicant may not personally operate the premises and no Class "B" Manager's license is held by anyone at this location.

There were also neighborhood objections to the renewal of the license due to allegations of excessive noise and disorderly conduct associated with the premises and/or its patrons.

4. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, on November 29, 2010, the City Clerk's Office provided timely notice of the police report, License Division correspondence and neighborhood objections to the Licensee. A copy of the police report and correspondence concerning management and control of the licensed premises was included with the notice. The matter was scheduled for a hearing on the police report and neighborhood objections on December 7, 2010 at 2:00 p.m. in Room 301B of the third floor of City Hall. At said date, time and place, the Licensee appeared and was represented by Attorney Andrew Arena 1110 North Old World Third Street, Suite 515, Milwaukee, WI 53203-1117.

5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. There were several neighbors who appeared to testify in opposition to this application. Testimony was offered that patrons of the licensed premises regularly engage in excessively loud, noisy, and disorderly conduct as the patrons enter and exit the premises. Testimony was offered that patrons consumed alcohol on the public sidewalk and engaged in loud and profane behavior. Neighbors stated that the noise and disruptive activity of the patrons ceased when the licensed premises served last year's 45-day license suspension and when the licensed premise did not permit its patrons to use the outside deck.

 - B. Staff of the City Clerk's License Division testified as to previous contacts with the licensee which strongly suggested that a person other than the licensee operated, supervised and controlled the commercial activity of the licensed premise contrary to § 90-9 of the Milwaukee Code of Ordinances. However, given the testimony of the license applicant that the other alleged operator was in state custody and would be incarcerated for the foreseeable future, the committee finds that a warning letter regarding the requirements of § 90-9 of the Milwaukee Code of Ordinances is sufficient and appropriate regulatory response.


CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based upon the above facts found, the Committee concludes that the licensee, Christina Elliott has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of her Class "B" Tavern, Tavern Dance, and Video Game Center license for the premises located at 4014-24 South Howell Avenue in the City and County of Milwaukee, Wisconsin ("Jersey's Sports Pub & Grill") without the issuance of a warning letter and an amendment to the licensee's plan of operation to not permit consumption of beverages outside of the tavern buildings on the premise's exterior deck(s).
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should renewal of her Class "B" Tavern, Tavern Dance, and Video Game Center license for the premises located at 4014-24 South Howell Avenue in the City and County of Milwaukee, Wisconsin ("Jersey's Sports Pub & Grill") with the issuance of a warning letter and an amendment to the licensee's plan of operation to not allow consumption of beverages outside of the tavern buildings on the premise's exterior deck(s).

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of two (2) ayes, one (1) noe and two (2) excused, recommends that the licensee's Class "B" Tavern, Tavern Dance and Video Game Center licenses be renewed with a warning letter, though the extension of premises should not be renewed due to amendment to the licensee's plan of operation to not permit consumption of beverages outside of the tavern buildings on the premise's exterior deck(s).

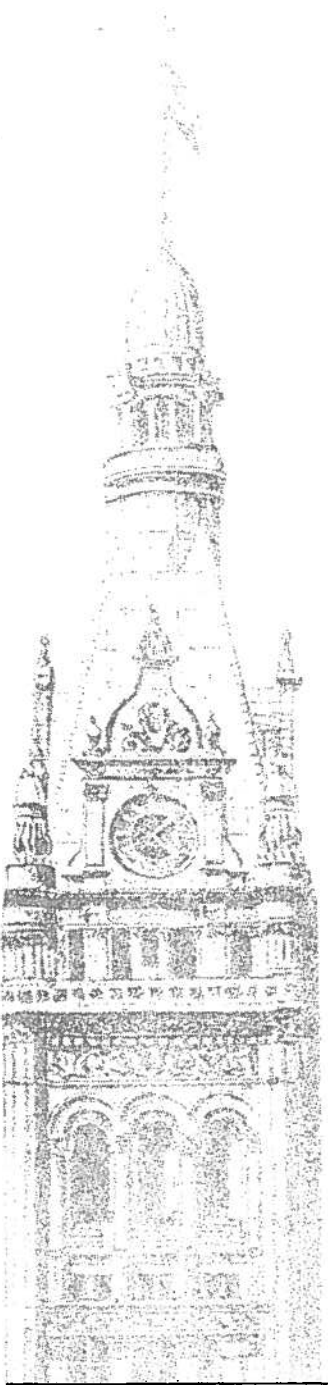

Re: Report of the Renewal Application of Kanisha T. King-Gray for a Class "B" Tavern and Tavern Amusement (Cabaret/Nite Club) license for the premises located at 2579 North Teutonia Avenue in the City and County of Milwaukee, Wisconsin ("Club Passion").

FINDINGS OF FACT

1. Kanisha T. King-Gray (hereinafter the "Licensee") is the holder of a Class "B" Tavern and Tavern Amusement (Cabaret/Nite Club) for the premises located at 2579 North Teutonia Avenue in the City and County of Milwaukee, Wisconsin ("Club Passion"). Said license expires at midnight, December 15, 2010.
2. An application to renew said license was timely filed with the Office of the City Clerk on October 4, 2010.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department responded with a report that could form the basis of non-renewal or suspension of this license on October 5, 2010. The hearing notice also stated that there were neighborhood objections to loitering, littering, loud music and noise, parking and traffic problems, drug and criminal activity, prostitution, trespassing, public urination, fights, shootings, vandalism, thefts, operation of the premises in such a manner that it creates a public nuisance, damage to private property, disturbing the peace, causing the normal flow of



traffic on roadways to be impeded, excessive and inappropriate use of police resources, neighborhood problems due to mismanagement, endangering safety by exceeding capacity, shootings and gunshots, and conduct which is detrimental to the health, safety and welfare of the neighborhood.

4. On November 24, 2010, the City Clerk's Office provided notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the police report that could form the basis for nonrenewal or suspension and the neighborhood objections and included a copy of the police report. The matter was scheduled for a hearing on the police report and neighborhood objections on December 2, 2010 at 9:00 a.m. in Room 301B of the third floor of City Hall. At said date, time and place the licensee did appear and was represented by Attorney James Turan.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On October 30, 2009 at 12:05 a.m., officers of the Milwaukee Police Department were dispatched to 2579 North Teutonia Avenue for large fight/shots fired complaint. As officers arrived, they observed several patrons scattered outside the club as well as several autos leaving the area. Once inside the club there was a strong odor of OC in the air with subjects coughing. Officers spoke to Douglas Gray, the licensee's husband who stated a fight broke between two patrons with other patrons joining in the fight. Security attempted to intervene but the patrons began to fight with security. Gray stated no shots were fired. Gray further stated he did not know who sprayed the OC and that maybe a female "snuck" it in. Attempts to speak with the bartenders were made but Gray stated that they had all left for the night. Officers also attempted to speak with the security guards but only one was left on scene. Officers spoke to Draylon Oliver who stated he was working at the entrance of the tavern and did not see what happened but did observe security guards pushing several patrons out the door. Oliver stated he knew the house security to carry OC on their person and believed it was a female security guard

name "Cory" who had used her OC. Police again spoke to Gray who stated he does not allow security to possess or use OC spray. Police eventually did speak with security guard Cacorey Edwards regarding this Incident that confirmed a fight did occur in the tavern but denied using OC. Gray stated the tavern does not allow them to use or possess it. Police did observe security cameras but were told by Gray that the system does not work. The licensee was issued citations for disorderly premises and responsible person upon licensed premise. Also Kanisha King-Gray was issued a citation for disorderly premises and responsible person upon licensed premise which were both dismissed without prejudice on April 9, 2010.

- B. On December 18, 2009 at 1:09 a.m. officers of the Milwaukee Police Department were dispatched to North Teutonia and West Clarke to investigate a shots-fired complaint that occurred outside of Club Passion. Upon arrival, officers observed an auto that had a bullet hole on the driver's side front door. Officers spoke to Douglas Gray who stated he was the owner of Club Passion and that it was his auto that was damaged. Gray stated he did not witness this happen and that he would not be able to access video surveillance equipment at this time. Officers then spoke to security officer Terry Atwater who stated he was working inside the club during the incident and did not witness anything. Officers spoke with a witness who stated he heard a few gunshots and then observed several females run from the area and into Club Passion. Police located eight 9mm casings that were placed on inventory. Unsuccessful attempts were made to contact Kanisha King-Gray.
- C. On December 27, 2009 at 12:55 a.m. officers of the Milwaukee Police Department monitored the closing of Club Passion due to the large crowds the club attracts. A check for capacity was conducted and the club was found to have 227 patrons with the capacity listed as 160. The club was over capacity by 67 patrons and this count did not include employees of the club. The capacity license was found to be behind the bar covered by two bottles of

liquor. While the count was being conducted, officers observed two patrons holding one full sized bottle of Absolut Vodka and another holding a full size bottle of champagne or wine. The licensee Kanisha King-Gray was not on scene and attempts to contact her were unsuccessful. The number that was listed as well as King-Gray cell phone number on the MINT system were found to be disconnected. On December 28, 2009 at 9:27 p.m., officers returned to Club Passion and spoke with Douglas Gray regarding obtaining valid phone numbers to Kanisha. Gray advised police that he did not have any updated/valid numbers to provide. An attempt to contact King-Gray at her residence (4422 North 85th Street) was also unsuccessful. On January 1, 2010 at 10:05 p.m. officers attempted to make contact once again with King-Gray at her residence and spoke to Douglas Gray's sister, Martha Walker, who stated she just moved into this residence and does not speak with Kanisha or have any information about her. King-Gray was cited for over capacity regarding the December 27, 2009 incident. Police attempted to serve the citation to Gray but he refused to accept them telling officers to talk to her attorney. Police are unable to list the proper information for this citation and future citations since they are unable to locate and or obtain personal information on the licensee, King-Gray. The licensee was issued a citation for exceeding posted occupancy capacity and found guilty on April 9, 2010 and fined \$10,000.

- D. On March 9, 2010 at 1:42 a.m. officers of the Milwaukee Police Department were dispatched to Mt. Sinai for a shooting complaint. Officers spoke to the victim who stated he left Club Passion at closing time with some of his friends and got into an auto driven by his girlfriend. The victim stated there was heavy traffic from the large crowd that was leaving the club when he observed a male firing a silver handgun "in every direction." The victim stated he heard three gunshots and "ducked" to avoid being shot. It was shortly after he realized he was shot in the left leg and right wrist. Police locate many casings throughout the block and placed them on inventory. Police also located the

auto the victim was in and found a pool of blood on the floor where the victim stated he was seated. Police attempted to obtain video surveillance but found Club Passion to be closed. On March 9, 2010 at 7:13 p.m. officers contacted King-Gray regarding the shooting who advised police she was unaware of this incident.

- E. On April 26, 2010 at 10:45 p.m. officers of the Milwaukee Police Department conducted a license premise check at 2579 North Teutonia due to receiving a complaint that the club had topless dancers on Monday nights. Officers entered the tavern and spoke with Douglas Gray and requested to see the tavern's liquor license. Officers observed a box of Black and Mild cigars, wine flavored, on the back bar. A check of the license found the tavern did not have a tobacco license. Police also found the tavern to be charging a \$15 dollar charge with no sign posted at the entrance about this over charge. When questioned by police, Gray stated he rented the bar out and that he has no control over what they charge. Police found the licensee information through the MINT system to show that she had not provided the new address and phone number of her contact information. The licensee was cited with citations for cigarette and tobacco license required and tavern charges to be posted which were dismissed without prejudice on August 3, 2010. The licensee was issued citation for failure to report change on liquor license and found guilty on August 3, 2010 and fined \$300.00.
- F. On May 21, 2010 at 1:40 a.m. officers of the Milwaukee Police Department were monitoring the closing at Club Passion when they observed a patron leave the tavern and walk to the side of the business and urinate on the building and sidewalk. The subject was cited and police spoke with Douglas Gray regarding this matter. Unsuccessful attempts to contact the licensee, Kanisha King-Gray, were made regarding this matter.
- G. On June 26, 2010 at 2:30 a.m. officers of the Milwaukee Police Department investigated a walk-in battery complaint at District Five, The victim

stated she was at Club Passion and that she has a temporary harassment injunction against a known suspect who was in the club. The subject approached her and she told him to go away when he slapped her. Security broke up the fight and kicked the subject out of the club. Once the club closed, the victim stated she went to District 5 to report the incident. Officers notified the bar manager regarding this incident.

- H. On August 8, 2010 at 1:30 a.m. officers of the Milwaukee Police Department were dispatched to Teutonia and Clarke for a shooting complaint. The investigation revealed a patron was shot while inside the club. Officers found the victim lying on the bathroom floor with two gunshot wounds to his hip and thigh. Witnesses stated that there had been a fight near the dance floor and bathrooms with security attempting to break it up. The witness stated shots were fired and believed two shots were fired inside and the rest were fired from outside of the tavern. Police spoke with Douglas Gray who stated a large fight broke out on the dance floor around 1:00 a.m. and that security went to break up when he heard two shots. Gray stated he then observed a subject fall to the ground. Gray further stated he did not observe who fired the gun. Requests to view surveillance video were made and Gray stated it was not operating at the time of incident. Gray stated he did have an operating ID card reader that takes digital photos of the person and was able to confirm to police that the victim was a patron at the tavern that night. A possible suspect ID was also recovered. Casings were recovered inside and outside of the tavern. A total of ten squads were needed at the scene to interview 35 possible witnesses. The Milwaukee Fire Department was also on scene. Attempts were made to contact Kanisha King-Gray via telephone regarding this shooting with no one answering. A battery complaint was also filed in addition to the shooting incident that also occurred inside the tavern shortly before the shooting occurred.
- I. On October 17, 2010 at 1:45 a.m. officers of the Milwaukee Police Department observed a security

guard physically restraining a subject while escorting him out from inside the establishment. This patron was yelling profanities which were causing a large crowd to gather and view the incident. This patron then walked up to another subject and punched him in the face, which caused a fight to break out. Officers requested more squads to the area to assist in breaking up this large fight. The patron who punched another subject was arrested and when questioned stated the fight began in the club and moved outside when security removed him. This subject further stated that security used OC in attempts to break up the fight inside the club. The subject was cited for disorderly conduct. Officers entered the club and found a strong odor of OC in the air. Police spoke with Douglas Gray who has stated to police in the past that he does not allow his interior security personnel to carry any weapons, which include OC. Officers made several attempts to contact Kanisha King-Gray via phone and in person, but were unsuccessful. A total of six squads were needed to clear the area and restore order.

- J. Several neighbors and employees testified before the Committee. The Committee finds that most witnesses indicated that behavior and activity associated with the licensed premise has improved from previous years.

CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based upon the above facts found, the Committee concludes that the licensee, Kanisha T. King-Gray who holds a Class "B" Tavern and Tavern Amusement (Cabaret/Nite Club) license for the premises located at 2579 North Teutonia Avenue in the City and County of Milwaukee, Wisconsin ("Club Passion") has not met the criteria of Chapter 90, of the Milwaukee Code of

Ordinances together with the police report to allow renewal of her license without undergoing a twenty-five (25) day suspension. The Committee finds the police report and neighborhood objections as stated above to be true.

3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern and Tavern Amusement (Cabaret/Nite Club) license of Kanisha T. King-Gray for the premises located at 2579 North Teutonia Avenue in the City and County of Milwaukee, Wisconsin ("Club Passion") with a twenty-five (25) day suspension based upon the police report and neighborhood objections.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes and two (2) noes, recommends that the Class "B" Tavern and Tavern Amusement (Cabaret/Nite Club) license held by Kanisha T. King-Gray for the premises located at 2579 North Teutonia Avenue in the City and County of Milwaukee, Wisconsin ("Club Passion") be renewed with a twenty-five (25) day suspension based upon the police report.

Said suspension is to be in effect between 12:01 a.m. December 16, 2010 through midnight, January 9, 2011.

Re: Report on the Renewal Application of the Class "D"
Bartender License of Carrie A. Wisniewski

FINDINGS OF FACT

1. Carrie A. Wisniewski (hereinafter the "Licensee") is the holder of a Class "D" Bartender License in the City and County of Milwaukee, Wisconsin. Said license expires at midnight, December 31, 2010.
2. An application to renew said license was timely filed with the Office of the City Clerk on October 28, 2010.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On October 29, 2010, the Milwaukee Police Department responded with a police report that could form a basis for non-renewal or suspension of said license.
4. On November 20, 2010, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report on December 2, 2010, commencing at 11:00 a.m. in Room 301B of City Hall. At said date, time and place, the licensee did appear and she was not represented by counsel.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On April 5, 2010, the licensee was issued a citation for littering on public property at 5300 West Vliet Street and found guilty on September 14, 2010 and fined \$144.00.



- B. On May 28, 2009, the licensee was convicted of operating while intoxicated and had her license revoked for seven months.
- C. On October 17, 2010, the licensee was convicted of BAC and had her license suspended for six months.

CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based on the above facts found, the Committee concludes that the Licensee, Carrie A. Wisniewski, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Bartender license without undergoing a twenty (20) day suspension of said license based upon the police report.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to renew the Class "D" Bartender license held by Carrie A. Wisniewski with a twenty (20) day suspension based upon the police report.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes and one (1) excused, recommends that the Class "D" Bartender License be renewed with a twenty (20) day suspension denied based upon the police report.

Said suspension is to be in effect from midnight December 31, 2010 and for twenty days thereafter.
