THIS IS A PROCEEDING TO consider the following applications as the first phase of the entire Power the Future project proposal: (1) application of W.E. Power and Wisconsin Electric Power Company (WEPCO) for a Certificate of Public Convenience and Necessity (CPCN) to construct and place in operation approximately 1,090 MW of combined-cycle gas-based generating capacity at the Port Washington Power Plant site; (2) application of Wisconsin Gas Company (WGC) for a Certificate of Authority (CA) to construct and place in operation a natural gas pipeline lateral to transport natural gas from the ANR gate station to the Port Washington Power Plant site, where that gas will be used to fuel the proposed generating capacity and reinforce the gas distribution system in the Port Washington area; (3) application of the American Transmission Company (ATC) for a CA to upgrade existing transmission lines and substations to support the new generating units at Port Washington; and (4) approval of a series

of affiliated interest agreements between WEPCO and the project companies in which W.E. Power has a majority ownership interest.

A Notice of Hearing was previously mailed on June 28, 2002, announcing both the public and technical hearing dates for this case. The technical hearings for this case are still on schedule to begin on September 18, 2002. However, the original date for public hearings (August 28, 2002) is being rescheduled to a later date following the conclusion of the technical hearings, so people in the affected communities can benefit from the information presented over the course of the technical hearings.

Copies of the construction applications are available for public review at public libraries throughout the project area. Copies of the construction applications are also available at the office of the clerks for each county, town, village, and city within close proximity of the project area.

NOTICE IS GIVEN that the public hearing has been rescheduled and will be held on Tuesday, October 1, 2002, at 1:30 p.m. and 7:00 p.m. in the Lakeview Hospitality Room at the Country Inn & Suites, 350 East Seven Hills Road, Port Washington, Wisconsin. This building is accessible to people in wheelchairs. A final prehearing conference, in preparation for the technical hearings, will be held on Friday, September 13, 2002, at 9:00 a.m. Technical hearings will commence on Wednesday, September 18, 2002, at 9:00 a.m. Both the prehearing conference and the technical hearings will be in the Amnicon Falls Hearing Room at the Public Service Commission of Wisconsin, 610 North Whitney Way, Madison, Wisconsin. This building is accessible to people in wheelchairs through the Whitney Way first floor (lobby) entrance. Parking for people with disabilities is available on the south side of the building.
