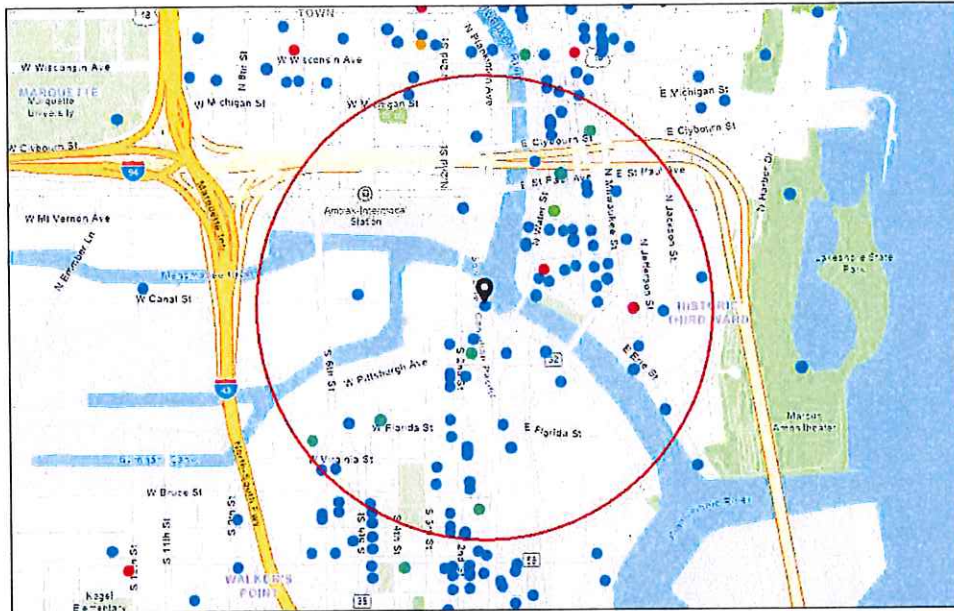


Concentration Map 106 W Seeboth St Unit 103-103A

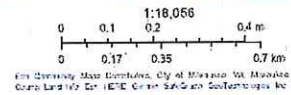

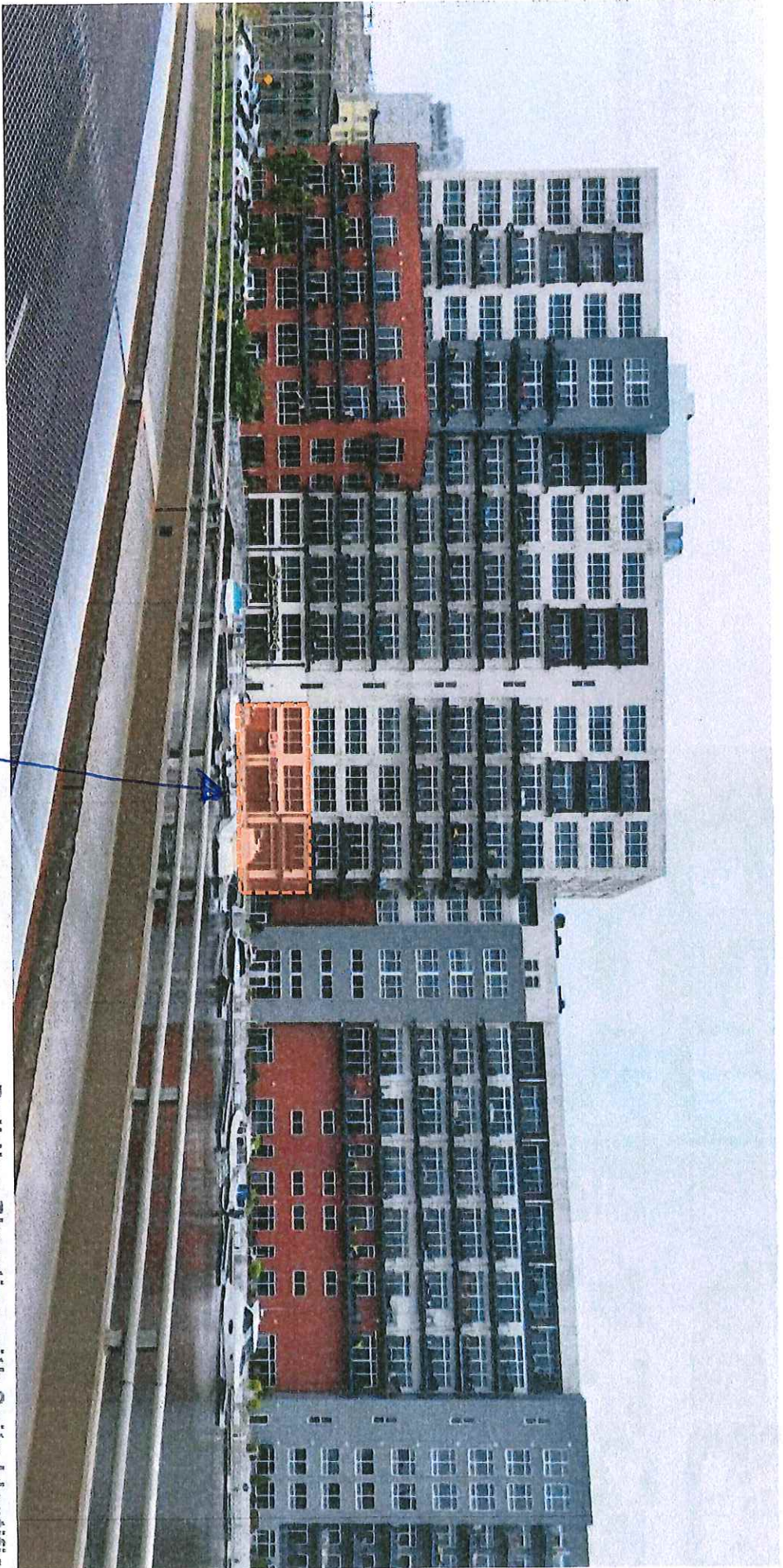
SECOND FLOOR PLAN
