There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 08/07/24 at 7:00p.m., Milwaukee Police were dispatched to Children's Hospital for a Sick and Injured. Investigation revealed a subject purchased gummies for their children at 6730 W. Villard, believing them to be candy, however, the parent later discovered they contained THC. The officers interviewed the employee who stated the adult purchased them and that's who they sold to. Video surveillance depicts the employee obtaining the item from under the counter and handing them to the children. There was a slight language barrier between the employee and officers, therefore some things were not accurately conveyed.
2. On 10/06/24 at 4:20p.m., Milwaukee Police were dispatched to a Robbery at 6730 W. Villard Ave. Investigation revealed a subject entered with a firearm in their waistband and took two vapes, then fled the store. On 10/13/24, the suspect returned to the store at which time the employee took the firearm, later determined to be a BB gun, from the suspect and called police. The suspect was arrested and admitted to stealing the vapes because they were not old enough to purchase them.

This report is written by P.O. Riley Y. O'CONOR squad 4234, assigned to District 4, Early Power Shift.

On Thursday, August 8, 2024, (while in full duty uniform, equipped with an activated Axon body camera, and a marked squad car) P.O. RAINEY and I were dispatched to Children's Hospital.

Upon arrival I spoke to the sister of one of the injured children, Kwa K PAW (a/f 05-14-2002) who stated that her sister, Juliana KUSAY (a/f 01-12-1997) had taken two children, to Rama Foods (6730 W Villard Ave) at approximately 7:00 PM on 8/7/2024. PAW stated while there the children were accidentally given THC gummies and had ingested a bag and a half of them before Juliana noticed and took them to the hospital.

I spoke to Juliana who stated she had taken the children to the store to get snacks. Juliana stated that they children grabbed several items of candy from the shelves and then pointed at what appeared to be a package of normal sour gummi worms with the "Trolli" branding on them under the counter. Juliana stated that the candy looked like the candy that they normally got in grocery stores, so she bought it along with the other items. Juliana stated the cashier then handed these items to the children who then ate a pack and a half of them in the store while Juliana continued shopping. Juliana stated she took the bag from one of the children to stop them from eating the whole bag at once at which time she observed the back of the bag which stated the item contained THC. Juliana stated that she then immediately took the children to the hospital.

P.O. RAINEY and I went to Rama Foods and spoke to the cashier who was working at the time of the incident, who provided us the name of Biejender BIEJENDER (a/m 08-19-1987). There was a language barrier between us and BIEJENDER so some things were not accurately conveyed but BIEJENDER stated that he gave the candy to Juliana who was the one that purchased the items.

P.O. RAINEY and I observed the video footage and observed BIEJENDER going under the counter, retrieving the THC gummies, and handing them directly to the two small children.

I informed the D4 Acting Lt of this incident and was instructed to file a sick and injured and licensed premise report regarding.

The children were admitted to Children's Hospital at 10:42 PM and were treated by Dr. Choi.

Wauwatosa PD responded to Children's Hospital and took possession of the THC gummies, packaging and receipt and filed an incident report under case number:24-23935.

On October, 6th, 2024 PO Brett STEGERWALD and PO Benjamin MARSHMAN responded to 6730 W Villard Ave, Rama Foods, (located in the City and County of Milwaukee) for an Robbery Complaint.

Upon arrival, Officers spoke to Bagender SINGH (A/M 1/9/87) who is an employee of Rama Foods who stated at 4pm an unknown black male who was later identified as Kyaire ROBINSON-WEST (b/m 12/27/2010 entered the store along with two other subjects. ROBINSON-WEST remains at the front counter with his hand around a black handgun which was in the front waistband. ROBINSON-WEST then points at Vapes which were kept behind the counter and walks behind and grabs two Vapes. SINGH stated he then walks up to the suspect in an attempt to stop ROBINSON-WEST when ROBINSON-WEST the grabs the black firearm from his waistband, displays the firearm, and pushes past SINGH to leave the store. ROBINSON-WEST then flees the location.

PO MARSHMAN recovered video of the incident and placed it on Evidence.com

On October 13th, 2024 PO Eric KRADECKI and PO Alfred HERRMANN responded to 6730 W Villard Av, Rama Foods, for a Subject with Weapon Complaint. Prior to arriving, the caller, Bijender, Bijender (W/M 8/8/87) stated he took the firearm from the suspect, who was identified on scene as ROBINSON-WEST. Officers arrived on scene and located ROBINSON-WEST. Bijender stated he feared for his safety due to ROBINSON-WEST being armed with a firearm. Officers recovered a black Glock 17 BB gun which had an empty black 9mm empty magazine inserted into the BB gun. ROBINSON-WEST was arrested for Disorderly Conduct and conveyed to District 4 for booking and processing and issued a citation for Disorderly Conduct.

While at District 4, I viewed a still photo from the Armed Robbery on October 6th, 2024 and confirmed ROBINSON-WEST to be the suspect who committed the armed robbery.

PO LEIDY conducted a mirandized interview of ROBINSON-WEST. During the interview PO LEIDY showed ROBINSON-WEST a still photo from the incident on October 6th in which ROBINSON-WEST confirmed that was him in the photo. ROBINSON-WEST then confessed to stealing the Vapes stating he stole them because he was not old enough to purchase them.

This ends my report.

The hearing before the Licenses Committee will take place on 5/20/2025 at 9:05 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.


