
Dear Ms. Mangan:


This office is in receipt of your claim in the amount of \$173.64, relating to damages sustained to your 1999 Pontiac when a City of Milwaukee snowplow allegedly struck it on December 30, 2000

The fleet accident report that was completed as result of this alleged incident indicates this is a well-traveled street that is used by numerous pieces of equipment and vehicles. Since no City driver has reported colliding with your vehicle, and you are unable to provide any information with respect to a truck or license plate number, we are unable to verify a City snowplow was involved. As such, the City can not accept liability. According, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, WI 53202, requesting a hearing.
