Dear Mr. & Mrs. Adamczyk:

We have received your claim in the amount of \$1,780.00, relating to damage sustained to your vehicle on January 21, 2006 when it collided with a City of Milwaukee truck in front of 5768 South 23<sup>rd</sup> Street.

Our investigation reveals that the Wisconsin Motor Vehicle Accident Report and the Fleet Accident Report completed as a result of this accident note that the City truck was making a left turn onto South 23<sup>rd</sup> Street. The Fleet Report also notes that the truck had completed the turn and was stopped in the road for 10-15 seconds while the driver examined the road conditions during a slowing operation. The witness said that the truck was stopped for 5-6 seconds. Your vehicle then rear-ended the truck. The liability for this accident is upon the driver of your vehicle. As such, the City cannot accept liability for your damages. Therefore, we are denying your claim.
