TAKE NOTICE that the Common Council of the City of Milwaukee, Milwaukee County, Wisconsin (the "City"), at a regular meeting held in the Common Council Chambers at City Hall, 200 East Wells Street, Third Floor, Milwaukee, Wisconsin, on September 21, 2021, adopted an Initial Resolution pursuant to Section 66.1103 of the Wisconsin Statutes, as amended, approving the issuance of not to exceed \$15,000,000 of revenue bonds of the City of Glendale, Wisconsin (the "Bonds") on behalf of Outreach Community Health Centers, Incorporated, a Wisconsin nonstock, nonprofit corporation (the "Borrower"), to complete a multi-jurisdictional project consisting of financing the (i) purchase of land, (ii) construction of an approximately 60,000 square foot facility (the "Facility") on a parcel of land owned by the Borrower located east of and proximate to the Borrower's existing facility located at 210 West Capitol Drive, Milwaukee, Wisconsin (the "Existing Facility"), with the majority of the property located in the City of Glendale and the remaining portion of the property located in the City of Milwaukee, which Facility will be used by the Borrower to provide healthcare services; (iii) acquisition and installation of furniture, fixtures and equipment at the Facility, (iv) renovation of the Existing Facility, and (v) payment of certain professional fees and costs of issuance (collectively, the "Project"). The Borrower has represented that 15 full-time jobs are expected to be created at the Facility as a result of the Project and that existing jobs will be retained.

Pursuant to the terms of Section 66.1103 of the Wisconsin Statutes, all requirements that the Project be subject to the contracting requirements contained in Section 66.1103 are waived, the Borrower having represented that it is able to negotiate satisfactory arrangements for completing the Project and that the City's interests are not prejudiced thereby.

THE BONDS SHALL NEVER CONSTITUTE AN INDEBTEDNESS OF THE CITY, NOR SHALL THE BONDS GIVE RISE TO ANY PECUNIARY LIABILITY OF THE CITY, NOR SHALL THE BONDS BE A CHARGE AGAINST THE GENERAL CREDIT OR TAXING POWERS OF THE CITY. RATHER, THE BONDS SHALL BE PAYABLE SOLELY FROM THE REVENUES AND OTHER AMOUNTS TO BE DERIVED PURSUANT TO THE REVENUE AGREEMENT RELATING TO SAID PROJECT TO BE ENTERED INTO BETWEEN THE BORROWER AND THE CITY OF GLENDALE, WHICH IS TO BE THE ISSUER OF THE BONDS.

The Initial Resolution may be inspected in the office of the City Clerk at 200 East Wells Street, Room 205, Milwaukee, Wisconsin, during business hours.

TAKE FURTHER NOTICE THAT THE ELECTORS OF THE CITY MAY PETITION FOR A REFERENDUM ON THE QUESTION OF THE BOND ISSUE. Unless within thirty (30) days from the date of the publication of this Notice a petition signed by not less than five percent (5%) of the registered electors of the City is filed with the City Clerk requesting a referendum on the question of the issuance of the Bonds, the Bonds may be issued without submitting the proposition for the electors' approval. If such petition is filed as aforesaid, then the Bonds shall not be issued until approved by a majority of the electors of the City voting thereon at a general or special election.
