Sewer Lateral damage as a result of tree planted by City of Milwaukee on City of Milwaukee land located at 4153 North 84th Street, Milwaukee, WI

On approximately, December 30, 2002, the outside sanitary sewer lateral was clogged and correspondingly the sanitary sewer backed up into our property located at 4151& 4153 North 84th Street, Milwaukee. The damage to the sanitary sewer lateral was the result of tree roots which were originally planted by the City of Milwaukee, on City of Milwaukee land, puncturing the sanitary sewer lateral piping from the sidewalk to the road, which is also City of Milwaukee land. The result of the obstruction of the sanitary sewer lateral was to cause the sanitary sewer line to back up and transfer sewage into the basements at 4151 N. 84th Street and 4153 N. 84th Street.

As a result of flooding in the basement the owner of the property, Mary Beth Doyle, contracted a sewer repair contractor, Kenway Services, to diagnose and remedy the problem. The sewer contractor took the first step in diagnosing the problem, and tried to locate the problem of the sewage back up. The sewer contractor used a

camera to diagnose the area where the blockage in the sanitary sewer lateral took place. According to the sewer contractor, Kenway Services, the sanitary sewer line was clear until the area at the sidewalk at the front of the property along 84th Street. The sanitary sewer line was possibly separated or crushed. On January 3, 2003, 3 hours of work took place in diagnosis and on January 6, 2003, 7 hours of work took place plus camera set up.

The sewer contractor, Kenway Services, was unable to access the sewer lateral line from the sidewalk to the street via cameras and other methods potetially used to clear the sanitary lateral. The area of the home from where the sanitary sewer line enters the building to the front of the sidewalk was free and clear of obstructions according to the sewer contractor. As a result, the diagnosis from the sewer contractor was the sanitary sewer line was probably crushed or separated at the area between the street and the sidewalk, City of Milwaukee land.

The following is a summary of the work which took place at 4151 & 4153 N. 84th Street, Milwaukee:

Claim #1:

□ \$1,540.00 (Diagnosis completed on January 6, 2003)

This work had to be completed in order to properly locate the location of the sanitary sewer lateral being plugged or clogged. A camera was used by the sewer contractor, Kenway Services to locate the blockage in the sanitary sewer lateral. Camera which was used was unable to get past the sidewalk at the front of 84th Street. The area between the front of the curb and the sidewalk was the source of the blockage in the sanitary sewer lateral.

Claim #2:

\$3,670 (Repair work completed on January 10, 2003)

An additional \$3,670, was spent to excavate and repair the sanitary sewer lateral between the front sidewalk and the curb, City of Milwaukee land. This work was done to restore the sanitary sewer lateral to its original condition, before the tree roots plugged the sanitary sewer line. The sewer contractor determined the source of the sanitary sewer lateral being non-operational, was the result of the large tree roots encroaching and puncturing the sanitary sewer lateral line to the road.

The end result is the tree which was originally planted by the City of Milwaukee on City property has caused approximately \$5,210 (\$3,670 repair of sanitary sewer lateral +\$1,540 diagnosis) damage to the sanitary sewer lateral. These bills will have to be paid by the owner of the property, Mary Beth Doyle. A copy of these bills is enclosed and accompanies this letter for a claim against the City of Milwaukee.

In short, Mary Beth Doyle, feels the City of Milwaukee should be responsible for the damage to the sewer lateral at the front of our property due to the City of Milwaukee tree's roots causing the blockage in the sanitary sewer lateral of our property and subsequently causing damage of \$5,210 to the property located at 4153 N. 84th Street.

Please contact me regarding this issue. Mary Beth Doyle, will be seeking legal counsel in this area. Could you please get back to me at your earliest convenience.
