Our office has received your claim relating to the towing of your car. You indicate that your vehicle was towed on May 10, 2001. You retrieved your vehicle on that same day and returned to the tow lot on May 16, 2001 and filled out a Complaint and Investigation form stating the tailgate of your vehicle had paint damage.

Our investigation reveals that your car was towed on May 10, 2001 for being illegally parked in a construction zone. The PT-27 indicates that there were scratches on the tailgate of your vehicle prior to the tow. The videotape taken when your vehicle entered the tow lot also confirms this damage. The damage to your car appears to have happened prior to the tow and therefore we are denying your claim.
