This is the second time this file has been heard by the Judiciary and Legislation Committee.

Milwaukee County Register of Deeds records indicate that the property was deeded via Quit Claim Deed to Kenny Marshall from Jonathan D. Marshall on 2/24/2022 as document #11220682.

This office has had the opportunity to review the above-referenced application, including whether the applicant has any outstanding debts with the Milwaukee Municipal Court. I am pleased to report that Milwaukee Municipal Court records indicate that the applicant, Kenny Marshall, has no such outstanding debt.

However, the prior owner Jonathan D. Marshall has over 100 outstanding "exceed max number parked vehicles on lot", "paved or approved surface required" and zoning violation judgments related to the property at 5024 N. 33rd St. as follows:
