2. On 06/04/24 at 4:54am, officers were dispatched to a shooting at 2002 W Capitol Dr. Officers arrived and located the clerk who had a gunshot wound to the leg. Investigation revealed that the suspect entered the location and fired multiple shots at the clerk who was in the service counter area. Casings were recovered at the scene and the business provided video of the incident in its entirety. The clerk was transported by MFD to the hospital.

The following incidents are calls for service at 2002 W. Capitol Dr.

3. On 09/06/24 at 11:15a.m., Milwaukee Police took a walk-in Violation of Restraining Order complaint. Investigation revealed on 09/05/24 at 9:00p.m., a known suspect violated a restraining order, when they entered the business and upon being escorted out, removed a pump nozzle, breaking the screen. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
4. On 11/08/24 at 12:30a.m., Milwaukee Police were dispatched to a Battery. Investigation revealed a suspect entered and attempted to make a purchase, however, did not have enough money. When the clerk locked the door to prevent the suspect from exiting with the items, the suspect displayed a firearm with an extended magazine. A second suspect was handed the items and both suspects fled the scene.

This report was written by P.O. Damon WILCOX, assigned to District 5 Day shift. On Friday September 6, 2024, at approximately 11:15AM, Squad 5122 (P.O. WALISZEWSKI and I) was dispatched to a Violation of a Restraining Order at S1 Metro LLC gas station at 2002 W Capitol Dr.

Upon arrival I spoke with the caller, identified as Sandeep SINGH (W/M, 8-9-98). He stated that he was an employee of S1 Metro LLC (gas station at the location). He stated that the business has a valid and served Harassment Restraining Order against a Subject that he identified as Sandra N LEE (B/F, 4-16-75). He stated that on Thursday September 5, 2024, at approximately 9:03AM, LEE came to the business and entered. He stated that she was told to leave the location. He stated that she refused to leave and was escorted out the front door of the business.

SINGH then stated that LEE ran to Gas Pump #1 and removed the gas nozzle. He stated that she used the nozzle to break the electronic display of the pump. SINGH stated that the damage to the pump is more than \$2500. I asked him how he knew the damage was that amount. He told me that she had broken the pump in a similar manner before and that was the reason the business had wanted the restraining order.

SINGH stated that he had video of the incident.

SCENE DESCRIPTION

The above listed location is a Clark gas station operating under S1 Metro LLC. I observed that the front door of the business faced N 20th St. I observed that the building of the business was on the West side of the lot. To the East of the building was a parking lot area. In this area I observed the gas pumps. Pump #1 was observed to have the entire electronic display screen broken and was not operational. I observed no further damage to the location.

VIDEO EVIDENCE

I viewed the video of the incident. The video did have a time stamp. It showed that on Thursday September 5, 2024 at approximately 9:00PM, a black female subject (wearing a white long sleeve shirt with a red stripe, tan three quarter length shorts, and white shoes). From the video, I knew this subject to be Sandra N LEE (B/F, 4-16-75) (from past dealings with her). LEE is observed to walk onto the business lot and then enter the business. LEE is observed to be escorted out the front door by staff

members.

LEE is then observed to walk over to Pump#1 and remove the gas nozzle from the pump. LEE then uses the nozzle to break the front display screen of the pump. LEE then again enters the business takes a bag of chips from the shelf and again exits the business.

DOCUMENTATION

A check of LEE revealed a valid Harassment Restraining Order (Milwaukee County Case # 2024CV006028) with her as the respondent and S1 Metro LLC as the petitioner. This restraining order was granted on August 7, 2024 and the affidavit of service was the same day.

P.O. WALISZEWSKI did upload the video and placed it on Evidence.com. I requested a Temporary Felony Want for LEE. This case will be submitted to the Milwaukee County District Attorney's for charging.

RELATED CASES

LEE had two other violations of Harassment Restraining Order for the same business (MPD case #C2408070088 and #C2408100100). Paralegal Adam Best charged both of these violations under ADA Kim SCHOEPP. A check of CCAP did not reflect these charged cases.

While on scene, I observed the licenses posted and they were up to date. During my investigation I did not observe any violations in the licensed premise

This report is being written by PO Tashumi WILLIAMS assigned to District 5, Late Shift, Squad 5320 with PO Dylan SCHARNWEBER.

On Thursday November 8, 2024, at approximately 12:30a.m., PO SCHARNWEBER and I were dispatched to a Battery at 2002 W Capitol Dr, a Clark Gas Station.

Upon arrival, I spoke with caller/victim Adel ABDULLAH (W/M, 8/22/2002).

On scene, ABDULLAH showed us security camera footage of the incident which occurred at approximately 11:30p.m. on 11/7/2024.

On the video footage, on 11/7/2024 at 11:29p.m., a silver 4-door Cadillac with an Indiana License Partial plate of CUN3, with an American flag design, front end damage, and a small hole on the front passenger side door, arrived at 2002 W Capitol Dr.

Suspect #1, a B/M, 18-25 years old, 5'10" thin build, black beard, wearing a black Nike hoodie, black sweatpants and white crocs exited the rear passenger door and entered the store.

Inside the store, suspect #1 grabbed items and walked them to the cash register. Suspect #1 did not have enough money to pay so he stated he would go to his vehicle to retrieve money to pay. At this point, ABDULLAH locked the exit doors because he did not want Suspect #1 to leave the store without paying. Suspect #1 became upset and stated "imma blow this bitch down". ABDULLAH then unlocked the front door and suspect #1 began walking to the exit with the two cigars and a drink which he did not pay for. ABDULLAH and another employee physically grabbed Suspect #1 and retrieved the items from his hands.

At this point, suspect #1 pulled a black handgun with an extended magazine out of his pants, and held it at his side. Suspect #2 then exited the driver seat of the Cadillac and approached the entrance of the store. Due to Suspect #1 holding the firearm, ABDULLAH instructed the other employee to hand the cigars and the drink to Suspect #2.

Suspect #1 then fled on foot north bound towards W Atkinson Ave and Suspect #2 entered the Cadillac and departed towards W Capitol Dr.

P.O. MEDEL and MENDOZA checked flock and found a full license plate of: CUN 339.

The license plate did not return to the vehicle. The vehicle was last observed on FLOCK at N. Sherman BL and W. Capitol Dr on Thursday, November 7th at 4:20 PM.


