

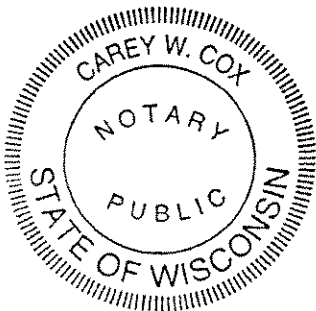

Notice is hereby given that an ordinance (passage of which is now pending) was introduced at the May 30, 2007 meeting of the Milwaukee Common Council, the essence of which is as follows:

Substitute ordinance relating to the change in zoning from Industrial-Office to Industrial-Light on land located on the North Side of East Keefe Avenue and East of North 1st Street, in the 6th Aldermanic District.

Resolved, That the Mayor and Common Council of the City of Milwaukee, do ordain as follows:

Part I. There is added to the Milwaukee Code of Ordinances a new section to read as follows:

Section 295-801(2).0007. The zoning map is amended to change the zoning for the area bounded and described by the zoning line within East Nash Street, the zoning line within North 1st Street, the zoning line within East Keefe Avenue, the centerline of North Palmer Street, a line 127.5 feet North and parallel to the north line of East Keefe Avenue, a line 141 feet East and parallel to the east line of North 1st Street, a line 165 feet North and parallel to the north line of East Keefe Avenue and a line 115 feet East and parallel to the east line of North 1st Street, from Industrial-Office (IO2) to Industrial-Light (IL2).

Notice is hereby further given that the foregoing matter will be given a public hearing by the Committee on Zoning, Neighborhoods and Develop-

ment in Room 301-B, City Hall, 200 East Wells Street, Milwaukee, Wisconsin, on Tuesday, July 3, 2007 at 9:00 A.M., pursuant to the provision of Sub-Section (7)(d) of Section 62.23 of the Revised Statutes of the State of Wisconsin.

PLEASE NOTE: a) Members of the Common Council, and members of its Standing Committees who are not members of this Committee, may attend this meeting to participate or to gather information. Therefore, notice is given that this meeting may constitute a meeting of the Common Council or any of its Standing Committees, and must be noticed as such, although they will not take any formal action at this meeting.

b) If you have difficulty with the English language, you may bring an interpreter with you, at your own expense, so that you can answer questions and participate in the hearing.

c) Upon reasonable notice, efforts will be made to accommodate the needs of disabled individuals through sign language, interpreters or other auxiliary aids.
