Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Notice for applicants with warrants or unpaid fines:

Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

This report is written by Police Officer Carlos Felix, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 03/27/24 at 12:11a.m., Milwaukee Police were dispatched to a Theft at 1300 W. College Ave. Investigation revealed a suspect entered and took items without paying, then left the establishment. A check of the business license revealed it expired on 03/22/24. The employee stated they were aware there was a hearing to renew the license on 03/26/24, and they had received an email confirming their scheduled shift, therefore, they came to work.
- 2. On 03/27/24 at 10:40a.m., Milwaukee Police conducted a License Premise Check at 1300 W. College Ave. This was in regard to prior knowledge the establishment's license was expired since 03/22/24. The officer interviewed the manager who stated they believed they were operating under a temporary license. The manager was advised a temporary license was not issued and to close the store, to which they complied.
- 3. On 05/17/2024, at 1:02 AM., an officer was dispatched to 1300 W. College Ave., Speedway, for a Theft complaint. A suspect entered the business and removed items without payment before fleeing. The employee working did not have access to security footage.
- 4. On 05/25/2024, at 12:37 AM., an officer was dispatched to 1300 W. College Ave., Speedway, for a Theft complaint. Unknown suspects entered the business and removed

- \$10.00 worth of donuts without payment before fleeing. Security footage did not provide a good description of the suspects. No business license violations were observed.
- 5. On 07/24/2024, at 4:17 PM., Officers were dispatched to 1300 W. College Ave., Speedway, for a Robbery. The suspect entered the business, implied they had a weapon and demanded money. Security footage was obtained of the incident. Employees were cooperative in the investigation and no license violations were observed.
- 6. On 01/25/2025, at 12:30 AM., Officers were dispatched to 1300 W. College Ave., Speedway, for a Robbery. Three suspects enter the location, one of the suspects goes behind the counter and pushes the employee down to the ground and grabs cigarettes. A second suspect goes behind the counter and also grabs multiple packs of cigarettes. There was a brief altercation with a witness and one of the suspects makes a threat to shoot them. All three suspects exit the location and flee. Security footage was obtained of the incident. Employees were cooperative in the investigation and no license violations were observed.
- 7. On 01/25/2025, at 5:10 PM., Officers were dispatched to 1300 W. College Ave., Speedway, for an Abduction Investigation. A female entered the business and stated she was going to hide in the bathroom. A male entered, stood by the bathroom door. When the female exited he grabbed her by the waist and carried her to a vehicle before driving away. An employee called for police service to reported the incident. The female was located, but refused police service. Security footage was obtained of the incident. Employees were cooperative in the investigation and no license violations were observed.

This report is written by Police Officer Rafael LOPEZ assigned to District Six, late shift.

On Wednesday, March 27, 2024, at 12:11 a.m., Squad (6350), I, responded to a Theft complaint at 1300 W. College Av., in the city and county of Milwaukee.

I was in full Milwaukee Police Department uniform with my badge and last name affixed to my outmost garment and equipped with an AXON body worn camera which was activated during the course of the investigation. I was also operating marked Milwaukee Police Department squad #089 with functional red and blue emergency lights and audible siren also equipped with an AXON camera system.

Observations/Scene

The above listed establishment is the Speedway gas-station and convenience store which is open 24 hours a day and is located on the northwest side of S. 13th St. and W. College Av. The main entrance to the establishment faces northbound leading to the interior of the establishment. In the interior there is a front counter and on the and is where the clerk provides customer service. The location is equipped with multiple video surveillance cameras.

The clerk cooperated with the investigation, appeared normal, was not in distress and had no injuries.

There was no physical evidence at the scene and no suspect.

Interview of Clerk

Jose A. RODRIGUEZ (w/m, 12-23-1980)

Upon arrival, I spoke to RODRIGUEZ who stated that on Tuesday, March 26, 2024, at 11:10 p.m. an unknown suspect described as a white male, 5'4"-5'5" tall, 160-170 lbs, blonde hair, blonde full beard, wearing brown glasses, a black coat with the hoodie over his head, and light bleached blue jeans walked into the Speedway. The unknown male walked in front of the counter where RODRIGUEZ was standing and the unknown male stated, "do whatever you gotta do" and proceeded to walk straight to the coolers located towards the back of the Speedway. The unknown suspect then reached into the cooler and grabbed 14 (12oz cans of Red Bull), 36 (8.4oz cans of Red Bull) and stuffed them in a black backpack. After the suspect stuffed the Red Bulls into the backpack he exited the Speedway and walked northbound on S. 13thSt.

There is no relationship between clerk and suspect, but the clerk did state that the same suspect has stolen items in the past. Seven weeks ago, the same suspect took items from the Speedway but was not reported to police. Four weeks ago, same suspect took items from the Speedway and was reported to police. Two weeks ago, the same suspect took items from the Speedway and was not reported to police only to management of the Speedway.

RODRIGUEZ stated that he does not have access to the surveillance video and has to contact the on-duty manager.

Interview of Witness

RODRIGUEZ stated that there were no witnesses at the time of today's incident.

Property taken was 14 (12oz cans of Red Bull) valued at \$55.86 and 36 (8.4oz cans of Red Bull) valued at \$114.84. Total amounting to \$170.70.

A link to <u>bostonski@outlook.com</u>was sent to the on-duty manager Boston SLOMANSKI (w/m, 9-28-2004) by phone to upload surveillance video of the incident.

While on scene, I observed the licenses posted and they expired on 3/22/2024. During my investigation for the Theft, I did not observe any other violations in the licensed premise. I notified Squad 6313 (Sgt. Kimberly ANDERSON) of the expired licensed.

I also spoke to SLOMANSKI in regard to the expired licensed who stated that on Tuesday, March 26, 2024, between the hours of 12:00pm and 1:00pm there was a hearing to renew the expired license and that he had confirmation on his work computer that was at Speedway. SLOMANSKI stated to me that he would be in at work later today around 5:00 a.m. and would provide me with the confirmation.

On Wednesday, March 27th, 2024, at 10:40 a.m., I, P.O. WATTS of Squad 6150 conducted a licensed premise check at Speedway located at 1300 W College Av, in the City and County of Milwaukee.

Upon arrival I spoke with the manager, Boston M. SLOMANSKI (W/M, 09-28-04, 414-317-4779) in regard to their license being expired. SLOMANSKI believed the store was operating under a temporary license. Sgt. Logan JEFFERY of Squad 6114 verified that a temporary license had not been issued.
