Good Evening,

I am writing to formally report two concerning incidents that occurred at the gas station located at 408 W. North Avenue on March 28, 2025, and March 30, 2025. These incidents raise serious concerns potential overcharging, and customer service at this establishment.

Incident #1 – Overcharging a Minor (March 28, 2025)

On Friday, March 28, around 9:00 PM, my husband and I stopped at the gas station. While inside, my husband witnessed one of his students, a sixth-grade child (approximately 11–12 years old), attempting to verify the change he received after purchasing three small bags of chips. My husband decided to stand and watch and not be noticed, to see what would happen.

- The student questioned the amount of change he received, stating he paid with a \$10 bill but did not receive the correct amount back. My husband said he know the student wasn't sure how much should have been returned but he knew he didn't get the correct amount.
- The cashier became aggressive, repeatedly yelling at the child to leave, despite the student calmly trying to resolve the issue. After hearing enough my husband decided he would step in.
- Upon review, my husband determined that the cashier had overcharged the student, ringing up each "2 for \$1" bag of chips as \$3 each, totaling \$9 dollars in total.
- When my husband pointed this out, the cashier silently corrected the mistake but did not apologize or offer any explanation.

This raised a serious concern for my husband regarding unethical business practices, particularly toward minors who may not be able to verify correct pricing and change in that area/neighborhood. He also pointed out there were no prices on the chips and that the chip aisle is always scare no matter what time of the day he goes in there.

Incident #2 - Refusal to Provide Refund (March 30, 2025)

On Sunday, March 30, I sent my son into the same gas station to purchase two bags of Lay's Hot Chips. However, when he went looking for Lay's Flamin' Hot, he was unable to find them, so he picked up a similar bag of chip, he bought Jay's Hot Stuff Chips instead.

- When I realized the mistake, I asked him to return the chips for the correct brand.
- My son could not find Lay's Hot Chips, and the cashier refused to issue a refund.
- When I entered the store to clarify, I was initially told I could exchange them, to get the chips I wants, I let him know the correct item was not available, I requested a refund.
- The cashier then claimed that refunds were not allowed, though no refund policy was visibly posted and I asked where was the "no refund sign" located.
- He contradicted himself, first stating that refunds weren't possible because my son paid with a credit card (which was false), I pulled the change given out of my pocket and then he said his register simply didn't allow refunds.
- He then said that he could only refund one bag, not both, which makes no sense, as if he could refund one, he should have been able to refund both.

Additionally, I noticed that there were no visible prices on the bags of chips, making it difficult for customers, especially children, to know how much they are paying before reaching the register. I started to notice a line forming so eventually, I left without a refund to avoid further back-and-forth.

9. On 01/03/19 at 2:41am, Milwaukee Police were dispatched to 1840 N. 6th Street for an armed robbery complaint. Investigation revealed that the caller/victim, who works at 1840 N. 6th Street, was 408 W. North Avenue when the incident occurred. The victim stated that he was at the filling station when he was approached by a subject with his hands under his hooded sweatshirt. Fearing for his safety, the victim pulled out his firearm for protection and the subject ran. The victim is a CCW holder and went to work before calling police.

10. On 08/08/19 at 10:00pm, Milwaukee Police were dispatched to 408 W. North Avenue for a trouble with subject complaint. Upon arrival, officers interviewed the caller who stated that she was having a conversation with two panhandlers inside the filling station who wanted her to buy them a charger. The employee locked the panhandlers out of the establishment by closing the metal gate to the entrance of the store. This action made the caller feel like a prisoner and she felt that it was unwarranted. She also felt like the employee believed that she stole items from the store to help the panhandlers. The caller said that she will be at the licensing meeting to speak about the incident.

- 11. On 12/19/2020 at 9:11pm officers conducted a license premise check at US Gas & Food Mart, 408 W. North Av. The officers located several expired food items throughout the store. The clerk was advised of the items and stated he would remove them from the shelves. The officers also observed two video gaming machines. The machines were plugged in and operating. The business did not have a PEP license. The officers contacted the applicant and advised him of the expired items and the unlicensed gaming machines. The applicant stated the machines are leased and he would take care of the expired items.
- 12. On 03/08/2021 at 3:12pm officers were dispatched to a Property Damage at US Gas & Food Mart, 408 W. North Av. The officer arrived on scene and observed a subject actively destroying items inside the store. The subject was arrested. The officers interviewed the clerk, who stated the subject refused to pay for items so they locked the door. The subject then began destroying the store.
- 13. On 07/11/2021 officers were dispatched to a subject with gun at US Gas & Food Mart, 408 W. North Av. The caller was the clerk, who stated a customer became upset and displayed a firearm, pointing at him. The officer observed video of the incident, which showed the customer producing a pistol and tapping it on the bullet proof glass. The clerk stayed behind the glass and the subject left when the clerk called the police. The clerk stated he wanted to prosecute.

14. On 08/26/21 the applicant was cited at 4295 W Roosevelt Dr., for Assault and Battery.

15. On 06/04/22 at 1:36pm, Milwaukee Police were dispatched to 408 W. North Avenue for a robbery complaint. Upon arrival, officers interviewed the workers who said they did not know of a robbery until the victim entered the store and told them he had been robbed. Surveillance footage captured the robbery which occurred in the parking lot of that location. Staff was cooperative with the investigation.

- 16. On 07/23/22 at 9:10am, a victim walked into the Fifth District Station House to report a theft. He told officers that he was at 408 W. North Avenue waiting for an Uber when he was approached by two subjects who said, "Give me everything you got." The victim gave the subjects his property. There was nothing of evidentiary value on the surveillance video.
- 17. On 08/07/22 at 8:11am, Milwaukee Police were dispatched to 408 W. North Avenue for an armed robbery complaint (original call was received by the Police at 2:53am). Surveillance footage revealed that two subjects approach the front window on the east side of the store and fire several shots at the window, then run northbound out of camera range. Since the window is made of bullet resistant material, 6 rounds hit the window, but did not go through.
- On 09/04/22 at 3:15am, Milwaukee Police were dispatched to 408 W. North Avenue for a shots fired complaint. Investigation revealed that someone had fired shots just north of the gas pumps.
- 19. On 09/26/22 at 3:30am, Milwaukee Police were dispatched to 408 W. North Avenue for an entry complaint. Investigation revealed that a subject threw a rock through the front window, breaking it, and took merchandise. The employee was cooperative and allowed officers to view surveillance footage.
- 20. On 11/28/22 at 7:29p.m., officers were dispatched to a Shooting at 408 W. North Av. On arrival officers observed the victim pulseless and not breathing with multiple gun shots to their body in the parking lot. Video surveillance depicted the victim exit the store and 3 suspects opened fire on the victim, shooting him at least 28 times. The employees were cooperative stating they did not see the incident, however, did hear the gunfire and upon observing the victim, they called for police.
- 21. On 01/18/23 at 6:56am, Milwaukee Police were dispatched to 408 W. North Avenue for a trouble with subject complaint. Investigation revealed that a customer was in a dispute with the clerk over gas money. The clerk refunded the customer.
- 22. On 02/07/23 at 9:15am, Milwaukee Police were dispatched to 408 W. North Avenue for an accident complaint. Investigation revealed that a vehicle drove over the hose of a tanker truck while it was refueling the filling station. The striking vehicle left the scene before police arrived.

- 23. On 03/06/23 at 11:45am, a virtual Teams meeting was held regarding the location of 408 W. North Avenue. The property was declared a nuisance property with a billing cycle end date of 09/01/23. Topics discussed during the meeting were; instructions on when employees should be contacting the police, educating employees on "no loitering" enforcement, and vehicles loitering in the parking lot. The applicant was receptive to the discussion but expressed frustration on how he is unable to control the actions of people outside his store and vehicles speeding down W. North Avenue. The officer offered to place a speed board in the area and toperform a CPTED on his business. The applicant accepted both offers.
- 24. On 06/08/23 at 8:00pm, officer working in conjunction with Wisconsin WINNS Youth Tobacco Prevention, conducted a compliance check at 408 W. North Av. The 17 year old buyer was allowed to purchase a tobacco product from the business. Officers spoke with the cahier who was apologetic for the sale. The agent was cited regarding the sale.

- 25. On 12/15/23 at 4:22am, officers were dispatched to 408 W. North Av, for a sick/injured complaint. Officers located a subject outside the business un responsive but breathing. The business was cooperative with the investigation. The employee was unable to provide video but the day employee could provide officers video access.
- 26. On 12/16/23 at 1:31am, officers were dispatched to 408 W. North Av, for a sick/injured complaint. Officers spoke with the caller who stated that the she observed a subject outside the business un responsive but breathing. The caller stated that he was near the gas pumps. Officer attempted to look over video footage, but the employee was unable to provide video. Officers were informed the day employee could provide video access.
- 27. On 05/24/24 at 9:15am, officers were dispatched to 408 W. North Av, for a shot fired complaint. Officers located 12 casing outside the business location. No victims were located regarding the shots fired. The business was cooperative with the investigation providing video of the incident. The video showed the incident in its entirely, the suspects, and suspect vehicle's information.

Item #24 updated with disposition

The following calls for police service pertain to 408 W. North Ave.

28. On 10/07/24 at 805pm., Milwaukee Police were dispatched to a Robbery. Investigation revealed the victim was pulled out of their vehicle by an unknown suspect after pumping gas. The suspect then fled the scene with the victim's vehicle. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident. There were no security officers on scene.

- 29. On 12/05/24 at 905pm., Milwaukee Police were dispatched to an Armed Robbery. Investigation revealed while the victim was sitting in their vehicle, an unknown suspect approached, displayed a firearm, and told the victim to get out of the vehicle, then fled with the victim's vehicle. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident. There were no security officers on scene.
- 30. On 02/14/25 at 210am., Milwaukee Police were dispatched to a Theft. Investigation revealed a suspect snatched the victim's car keys out of their hand, while they were inside the business, then fled with the victim's vehicle. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident. There were no security officers on scene.
- 31. On 03/31/25 at 922pm., Milwaukee Police conducted a License Premise Check. No violations were found other than a few expired items. The business was cooperative.
- 32. On 04/29/25 at 458am., Milwaukee Police were dispatched to an Overdose. On arrival officers observed the victim foaming and spitting inside the business. MFD was on scene and the subject was conveyed to a hospital for medical clearance.
- 33. On 05/21/25 at 816pm., Milwaukee Police were dispatched to a Shooting that occurred at 324 W. North Ave. Investigation revealed one of the suspects involved may have been at the gas station prior to the incident and an employee's vehicle was damaged as a result. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

This report is written by P.O. Brian PFEIL, assigned to District Five, Early Sift, Squad 5241.

On Monday, October 7th, 2024, at approximately 8:05 PM, P.O. SINLETON and I were dispatched to a robbery (just occurred) at N Vel R Phillips Ave and W North Ave. It was later determined that the robbery occurred in the parking lot are of 408 W North Ave, which is located in the city and county of Milwaukee, at the Citgo Gas Station.

Upon our arrival I observed the gas station to still be open with the front entrance (south) to be unlocked and with the interior of the store illuminated. Squad 5221 P.O. HOOVER was already on scene and was inside speaking with staff and was reviewing surveillance footage.

I spoke to the caller, later identified verbally as Maricela FLORES (F/H 07-18-2001), who was reporting that her vehicle was taken by an unknown male subject while he was brandishing a handgun. FLORES stated that she was parked at Pump# 3 facing eastbound and had finished pumping gas. FLORES stated that she was getting gas while coming from Racine, WI to pick up her boyfriend who had gotten off of work in the area. FLORES stated that while she was seated in the vehicle, the male suspect approached the vehicle and knocked on the window and demanded the victim get out of the vehicle. The suspect then fled the area in the victim's vehicle, which was later identified as a silver 2015 Kia Optima bearing WI plate# AUV5616.

There were no witnesses on scene during this investigation, but FLORES stated that after the robbery had occurred, there was a male on scene who witnessed the robbery and called for police services for FLORES.

I spoke to licensed premise *employee, later identified verbally as Karan SHARMA (M/A 06-13-2002).* SHARMA stated that they did not observe anything related to the carjacking that occurred in the filling area of the gas station. The business was cooperative with the investigation and allowed officers to check their permits and surveillance footage. The business had no security officers on scene at the time of this incident.

P.O. HOOVER reviewed video surveillance footage. P.O. HOOVER observed footage from two (2) outdoor cameras that showed what appeared to be a male subject, approximately 6'01" tall wearing a gray or

white baseball cap, red hoodie or red mask covering their face, black jacket, black athletics type pants with white stripes on the side and black tennis shoes.

I observed the subject walk up to the gas station from the northeast and approach the victim, a Hispanic female who was sitting in the driver seat of a silver in color sedan at pump #4. I observed the subject pull the victim out of her vehicle and then got into the vehicle, driving east out of the gas station and then north on N Vel R Phillips Ave.

While on scene, I observed the licenses posted and they were up to date. During my investigation for the robbery, I did not observe any violations in the licensed premise. I observed the business to have their Certificate of Occupancy, Extended Hours, Underground, Food and Cigarette & Tobacco permits posted on the interior side of the front employee door and none were observed expired.

Upon our arrival I observed and were met by caller/victim MAYNA GONZALEZ (B/F 12/30/06). GONZALEZ stated that while her boyfriend Taijuan L JAMES (B/M 3/23/01) was inside the gas station, an unknown female approached the driver side of the vehicle GONZALEZ was sitting in the passenger seat of and pointed a silver handgun at GONZALEZ demanding her to exit the vehicle. GONZALEZ did, and a navyblue CHEVY EQUINOX driven by an unknown black male pulled in front of victim's vehicle. The unknown black female got into the driver seat of victim's vehicle and the female drove off in the victim's vehicle and the blue equinox followed. The vehicles were last seen traveling southbound on N VEL R PHILLIPS AVE.

I spoke to licensed premise agent Nagra S GURINDER (7/30/70). The business was cooperative with the investigation by allowing officers access to video footage that captured the incident directly outside the business. The business had 0 security officers on scene.

I reviewed video surveillance footage. The footage showed JAMES walking to the driver side of the blue equinox and appeared to have a short conversation with the driver prior to entering the gas station. Once JAMES entered the gas station is when the unknown female suspect exited the equinox and demanded GONZALEZ to exit the vehicle. The video footage also shows the two vehicles traveling south on N VEL R PHILLIPS AVE. GURINDER was able to provide officers access to the camera system in the back of the store and allowed officers to collect footage for further investigation.

While on scene, I observed the licenses posted and they were up to date.

Multiple casings were recovered at 2345 N Vel R Phillips. On arrival a victim was pronounced PNB. A witness stated a white vehicle seen leaving the gas station at 408 W. North was involved. The white vehicle is believed to be the suspect's vehicle per witness statements.
