- Replacement of garage roof using or replacing it with GAF Timberline HDZ shingles with Staingward plus Algae Protection and wind Proven Infinite Wind speed protection in Tox Hollow Gray which is the same material and color as the roof of the house. The roof of the house was replaced in 2020.
