***PLEASE NOTE: A zoning change is being considered for the property within the boundary shown on the map on the reverse side of this notice. If your property is not within the zoning boundary, then you are receiving this notice because your property address is within 200 feet.***

### **DEAR PERSON OF INTEREST:**

The Common Council has referred file number 211865 to the City Plan Commission (CPC) for recommendation. This file relates to the change in zoning from Industrial Office, IO2, and Two-Family Residential, RT3, to Parks, PK, for the reconstruction and expansion of an existing neighborhood park on the properties located at 3814 and 3840 North 29th Street, and 2900 and 3010 West Hopkins Street, on the south side of West Melvina Street, north of West Hopkins Street, in the 7th Aldermanic District.

This zoning change was requested by the Department of Public Works and will allow the consolidation of these sites into one zoning district for the reconstruction and expansion of Melvina Park, including improved recreational facilities, restoring wildlife and pollinator habitat, community gardening, and providing opportunities for community gatherings, educational experiences, and nature-based play. **Please refer to the reverse side of this notice for map details.**


