My name is Sadhna Morato-Lindvall, and I am writing to request a hearing. Dear Ms. Morato-Lindvall:

This office is in receipt of your claim in the amount of \$638.77 relating to damages sustained to your vehicle when you collided with a damaged wheel stop on July 19, 2002 in the City parking lot located at North Water Street and East Juneau Avenue.

The Department of Public Works indicate they had no knowledge of any problems in this parking lot. Upon notification of the problem with the wheel stop, the department responded within twenty-four hours and filled the depression with asphalt, re-set and secured the wheel stop. Prior to this complaint the division had no notice of the condition, as such, the City cannot accept liability for this loss. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter with in 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.



RECORD OF ACCOUNT:

On Friday, July 19, 2002, I was employed with the City of Milwaukee as the Milwaukee Health Department's Communications Officer.

I drove my personal vehicle, a 1999 Mazda 626 from the Zeidler Municipal Building around 1:30 p.m. I returned an hour later with the intention of parking in the City parking lot near the corner of Water and Juneau. As a city employee and manager at the Milwaukee Health Department, this is an area I had credentials to park in (blue tag) and often used for parking.

As I attempted to park, I chose to back my car into a parking spot adjacent to the sidewalk, and close to the bus shelter. I looked to see if the area was clear, and as I slowly backed into the spot, I heard a thud, stopped, and then slowly drove forward. I parked the car, and got out to see what had caused the noise. I was disappointed to see the entire concrete wheel stop, which normally would be flushed against my car's tires, was pulled up, and an approximately 12 inch long piece of rusty rebar from the wheel stop was poking through my car bumper, pulling it off the car on the right side. I called 911, and Health Operations Director Bevan Baker to let him know what had happened.

No other car was involved. Afterwards, I noticed a big "X" on the sidewalk next to the wheel stop. The wheel stop was in a state of disrepair, and the rebar reinforcing was exposed throughout. I took pictures of the scene.

While the Police were arriving, I called Yvette Rowe, our business manager, who contacted the person in charge of city parking lots. DPW responded to the scene within the hour to review the condition of this parking stall. The concrete wheel stop was subsequently replaced.

Police officer Tom Ziesemer and Sergeant Amsler (District 1) arrived at the scene, and took additional pictures with their camera. Both the officer and the sergeant informed me that my car must have dipped into a pothole in the pavement, enabling my bumper to wrap around the damaged wheel stop. They also noted that the faulty barrier was marked on the sidewalk, but there was no marking to prevent anyone from parking, or that would be visible to a driver trying to park. Officer Ziesemer informed me his report would be sent to the City Clerk's office. If you have trouble locating his report, please call him at (414) 435-7212 (414) 559-8869.

As for taking care of the damage, I could not drive my car home because the bumper rubbed against the tires. I called my auto insurance agent (Bob Vitt/State Farm Insurance) to see what I should do. They recommended five locations near the accident, and the only one that could take me right away was American Auto-Beauty CARSTAR on Farwell Street. I had no other way of getting home, so I took the car to CARSTAR and rented a car to get home.
