Dear Ms. James:

We have received your claim for the amount of \$25,244.93 in relation to the vehicle damage you sustained on June 18, 2014 on North 25th Street between West Burleigh Street and West Chamber Street.

The Infrastructure Services Division reports asphalt patching on the 3000 block of North 25th Street was completed on May 16, 2014. Infrastructure did not receive any calls or complaints prior to your June 18, 2014 accident. A street maintenance supervisor was called to the 3000 block of North 25th Street on June 18, 2014 and acknowledged your accident. He observed your vehicle in a hole next to a catch basin. A tow truck pulled your vehicle from the hole, and the driver of your vehicle drove away.

Because the City did not have any notice of the allegedly defective condition, it cannot be held liable. Therefore we are denying your claim.
