Dear Council Members:

Ms. Brittney McIntosh submitted a claim for damages sustained to her 2016 Ford Escape, as a result of a homicide investigation, while her vehicle was parked at the Brown Deer Shopping Mall. Ms. McIntosh submitted damage estimates in the amount of \$9,748.28.

We have completed our investigation with Milwaukee Police Department (MPD) and City Tow Lot. Our investigation determined that June 21, 2025, MPD was dispatched to 8223 W. Brown Deer in response to a homicide investigation. The subject vehicle sustained multiple bullet holes, and was towed to the City Tow lot and held as evidence. A search warrant was executed in order to extract the bullets from the vehicle as evidence for that investigation.

It is our view that Milwaukee Police and City Tow Lot acted within the scope of their responsibilities. As such, the City is not liable for damages, and we recommend that the claim be denied.
