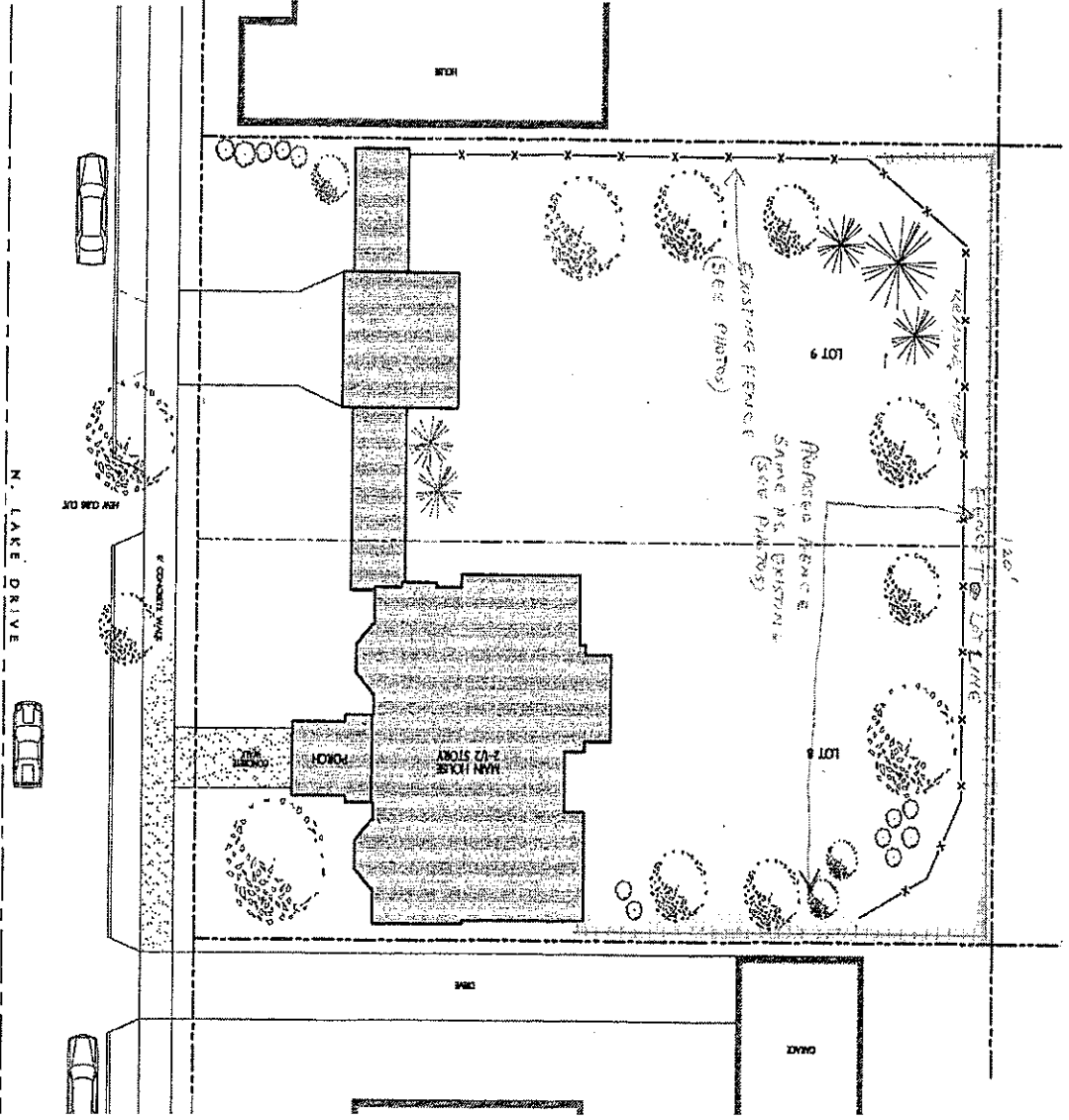
All work will be done according to attached drawings and files. Fence will be stained upon completion. Height will be 6'-0" and will be only the backyard.

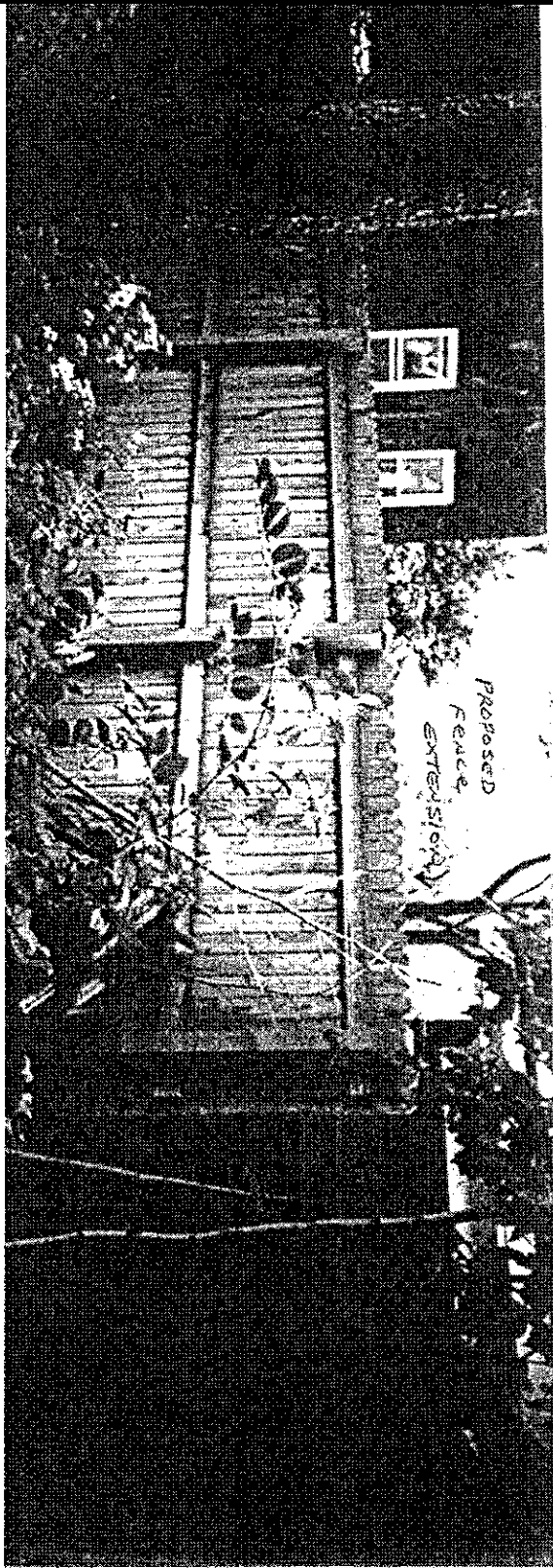


