The other individual I don't believe is 20 present, David Capon, from Washington Boulevard. 21 I've had no problems with this tavern as a 22 result of the last several years in which it has been licensed. I've received no complaints from neighbors 23 24 other than one rare complaint. And, in fact, the 25 neighbors have -- in my experience involving matters

00007 involving licenses before this committee in the last 1 2 14 years, I've not ever received so many calls in 3 support of a tavern, which is a testament to the two 4 owners. They have done a good job of being responsive 5 to the neighbors. 6 Now, this doesn't mitigate the fact that 7 they made an extreme error in poor judgment to say the least. It's pretty clear -- I think anyone who's had 8 9 an opportunity to watch the Channel 4 segment saw a 10 situation which was unacceptable. We had a situation 11 where Milwaukee police officers, who should know 12 better, were acting contrary to the law by attending 13 this establishment when it should have been closed. 14 They know better, and obviously that's a disciplinary 15 matter that the Milwaukee Police Department is 16 handling and should handle. 17 The owner should receive a fine and should 18 have his day in court, and I believe they're guilty, 19 clearly, at least in my opinion, and I think they 20 should be fined by the municipal court judge. But I 21 have not received any request from any of the citizens 22 in my district asking for this tavern license to have 23 any revocation of this license or suspension. 24 So what I would like to hear is for the 25 applicant to talk to this committee, talk to the

00008 community at large, at what they're going to do about 1 2 making sure that this never occurs again. 3 Obviously I don't think the police department will be having any an-after hour parties 4 5 there again or riding cars in the streets, but 6 notwithstanding that, I want to hear from the 7 applicant how he plans to acknowledge this as an error 8 in poor judgment and how he plans on addressing this 9 issue. 10 CHAIRMAN BOHL: Mr. Hunt, if you'd like to 11 respond on behalf of your client. 12 MR. For 4 three years O'Briens has been neighbor and fellow 5 business owners. They are hard-working, conscientious 6 and caring. 7 In the winter O'Briens has shoveled my sidewalk. When my lawnmower broke, O'Briens has lent 8 9 me theirs. When I needed help carrying something 10 inside, Brian or Joey or another employer were always 11 there to help. When someone suspicious or something 12 suspicious was going on in the neighborhood, O'Briens 13 was there.
