Licensing Committee,

Please allow this communication to serve as notice to the committee, that there are several neighborhood objections to the renewal of a Class B Tavern license for the business currently known as The Red Dot, premises and business owned and operated by Martin Beaudoin and housed at 2498 N Bartlett Ave. The Red Dot's license expires on May 19, 2007.

As the next door neighbor of this business and the Chair of our Neighborhood Association, I can not see how it is in the best interests of my family and our neighborhood to allow this business to continue operations in manners that detract from our quality of life and cast a negative light on our once quiet neighborhood.

I have reviewed Chapter 90, LIQUOR AND TAVERN REGULATIONS, and cite 90-12-f and other sections to support my objection to the renewal of licensing to this establishment:

90-12-f The licensed premises is operated in such a manner that it constitutes a public or private nuisance or that conduct on the licensed premises, including but not limited to loud and raucous noise, has had a substantial adverse effect upon the health, safety or convenience and prosperity of the immediate neighborhood.

Since it has opened, in August 2005, this establishment and its patrons have conducted themselves in illegal and inconsiderate ways. This establishment has been very detrimental to our family's schedule and to the peace and safety in our home and that of the surrounding neighborhood.

I would like to present evidence to this in the form of a narrated and subtitled DVD, a personal journal chronicling events, copies of issued citations, copies of communications via email, and statements from various publications regarding this establishment. I would also like the opportunity to appear at the committee hearing to support my objection.

Please allow these forms of evidence to be reviewed by the committee and added to the record.

Also note for the record that there were 3 separate noise citations received by The Red Dot's owner and staff. I ask that these also be reviewed by the committee and added to the record as evidence.
