Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

I see the autobody shop at "4030 South Pine Ave" has applied for an "Occupancy" permit...Please stop this permit from happening! There has been no changes from the Dept of Neighborhood Services, except the lacquer-smell is only about once a month. They are still working 7-days a week to the hours of 9PM to 9:30PM and cars still racing their engines, plus their doors are still open and letting the noise out! Car alarms are still going off for up to an hour during the morning hours. They are still storing cars in the back and are NOT moved for 30-days. They still do not have any respect for their neighbors.

Dear Alderwoman Marina Dimitrijevic:

My neighbors and myself have had major problems with the autobody repair business at "4030 S Pine Avenue" and here are just a few of the problems occurring:

Lacquer paint in the air, overhead doors are open letting out all the air-tool noise, hammer pounding, die-grinders and radio-playing too loud, the doors are suppose to be closed at all-times. Vehicle-engines racing at a high-RPM (day and night to about 11pm). Racing cars down Pine Avenue or testing them when leaving, working on cars outside by reviving engines and pounding on them, the law says they cannot work outside. They park cars all the time next to the North-fence there is "no parking". They leave cars and trucks parked along this fence for half-hour or more at a time (diesel engines). The people at this autobody shop harass the neighbors to the North (homeowner). They park so many vehicles on the North-side of the building that [redacted] was waving a gun at them, because he could not drive-thru to his part of the property.

We have called the police department and they are informing the neighbors calling, that it is a "Department of Neighborhood Service" problem. My neighbors have called Matt Dama, Special Enforcement and his Supervisor, Peter Laritson, tells Matt to stay away. We are working with Anthony Goodman and Brendain Sullivan regarding the "paint-smell" and a few other things.

The neighbors and I, have been trying to outlaw/ban autobody shops in our area and in trying to do this, we have been to approximately eight BOZA meetings and five Common-Council meetings only to find out that someone changed the zoning for this property. This zoning-issue is so strong, that there is an umbrella protecting them. The neighbors and I are demanding this zoning be reviewed and changed, so there would be no more autobody repair shops of any kind allowed in our area.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
