
This office is in receipt of your client's claim in the amount of \$50,000.00, relating to damage sustained to his vehicle on April 19, 2001 when he collided with a City police vehicle at north 36th Street and West Locust Street.

Our investigation reveals that the Wisconsin Motor Vehicle Accident Report completed as a result of this accident note that the Milwaukee Police Department was operating in an emergency capacity with it's warning lights and siren activated and entered the intersection. Your client failed to yield the right of way and was cited. The liability for this accident is upon your client. As such, the City cannot accept liability for your client's damages. Accordingly, we are denying your client's claim.

If you wish to appeal this decision on behalf your client, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
