## **DESCRIPTION OF PROJECT**

In March, 2014 an unknown driver, turning west on to Center Street from northbound Sherman Blvd, lost control of the car and piled into the mounds of snow that had been plowed and accumulated on the north side of Center St and along the south side of our basement. The resulting collision caused the snow and debris to destroy one of our windows leaving a gaping hole in the building.

The church decided to get the damage fixed immediately to avoid more snow and water from coming into the building and obviously having heat available to our basement on the south side of the building. Neither our contractor (J. H. Hassinger) or the church was aware of the need to consult with the Historic Preservation Commission for the replacement of the window.

At this time, we now submit the Certificate of Appropriateness for the Commission's review and acceptance.
