
Dear Sir or Madam:

I have been asked by my client, James R. Koenig, owner of the above noted property, to contact your office regarding a work order issued by your office on February 21, 2003.

As a result of a basement water leak at that location, Inspector Tony Brzozowski visited the property and ordered my client to immediately repair what he identified as a leak on the water service between the curb stop and the water meter (Work Order attached). This assessment was made on the basis of a visual inspection alone, i.e. without the use of any testing equipment. Mr. Koenig responded immediately to the order by engaging Gene A. Wagner Plumbing Co., Inc. to "correct" the problem (Wagner invoice attached). Their inspection of the water service between the curb stop and meter revealed no leak. Rather, a leak was found in the building unrelated to city water lines.

Kindly contact my office regarding Mr. Koenig's claim for reimbursement for the unnecessary work ordered by the Inspector.
