

, am writing to formally express my strong objection to the application for a Class A Fermented Malt and Food Dealer Retail license submitted by Gurmaio Singh, representing Saiguru Mail Inc. (dba BC Supermarket), for the premises located at 4225 W North Ave. My email address

My objection stems from a deep concern for the well-being and existing character of our neighborhood. It is my firm belief that the introduction of another establishment primarily focused on the sale of fermented malt beverages would be detrimental to the community residents. The area surrounding 4225 W North Ave is already adequately served by similar retail outlets, and the addition of another liquor store is simply not needed and would bring more harm than benefit.

Specifically, I anticipate a significant increase in both vehicular and pedestrian traffic to the location, particularly during late hours. This heightened activity can lead to increased noise pollution, parking congestion, and a general disruption of the peace and quiet that residents expect in our community. Furthermore, establishments of this nature often regrettably attract loitering, which can contribute to an unwelcome atmosphere, increased litter, and potential public disturbances, diminishing the safety and enjoyment of public spaces for families and children.

The presence of an additional liquor store can unfortunately be associated with an uptick in incidents of public intoxication, petty crime, and other forms of disorder. Such developments directly undermine our collective efforts to foster a safe, clean, and vibrant neighborhood environment. It is crucial that decisions regarding new business licenses prioritize the existing quality of life for residents over commercial expansion that could negatively impact community standards and safety.



For these reasons, I respectfully urge the Licensing Authority to give serious consideration to these significant community impacts and deny the aforementioned license application. Our neighborhood deserves careful thought to maintain its residential integrity and safety.

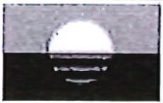

To the Esteemed Committee,

I am writing as a concerned resident of this community to express my profound opposition to the application submitted by Gurmaio Singh for a Class A Fermented Malt and Food Dealer Retail license for BC Supermarket, located at 4225 W North Ave.

Our neighborhood is presently well-served by, and arguably saturated with, similar retail establishments. The introduction of yet another outlet offering fermented malt and food for retail sale would provide no discernible advantage to the community; rather, it stands to introduce a host of significant and detrimental consequences that directly undermine the quality of life for its residents.

Granting this license would undoubtedly exacerbate the already critical issues of traffic congestion and parking scarcity within our residential areas. The increased volume of customer vehicles, coupled with augmented delivery truck traffic, would strain our limited on-street parking and thoroughfares, leading to increased delays, blocked access, and heightened safety risks for pedestrians and children.

Furthermore, an additional establishment of this nature is highly likely to contribute to an undesirable surge in ambient noise levels. This would stem from increased evening and late-night customer activity, vehicle movements, and potential loitering, directly infringing upon the peace and quiet that residents expect and deserve, particularly during off-hours.

Most critically, the proposed license poses a tangible threat to the safe and family-friendly environment that we, as a community, have diligently worked to cultivate and maintain. Experience suggests that such establishments can regrettably attract increased instances of loitering, public disturbances, and associated undesirable behaviors. These outcomes would directly erode the sense of security and tranquility, making our streets less welcoming for families and diminishing the overall appeal of our neighborhood as a place to live.

I implore the committee to give paramount consideration to the well-being, established character, and expressed concerns of the residents. Approving this application would represent a step backward for our community, sacrificing established peace and safety for negligible, if any, public benefit. I respectfully urge you to deny this application.

**ADDITIONAL COMMENTS/RECOMMENDATIONS:**

I spoke with the owner and operator, Gurmail SINGH, who stated he took over the convenience store in August. SINGH explained that he purchased the store along with all of its existing inventory, which included glass tire gauges, glass pipes, and Chore Boy displayed near the front entrance. I informed SINGH that these items are commonly associated with drug use and could create problems both for the surrounding area and for his business, and that they should not be sold. SINGH stated that few customers request those items, that he was unaware of their use in drug activity, and that he will refrain from ordering them in the future.

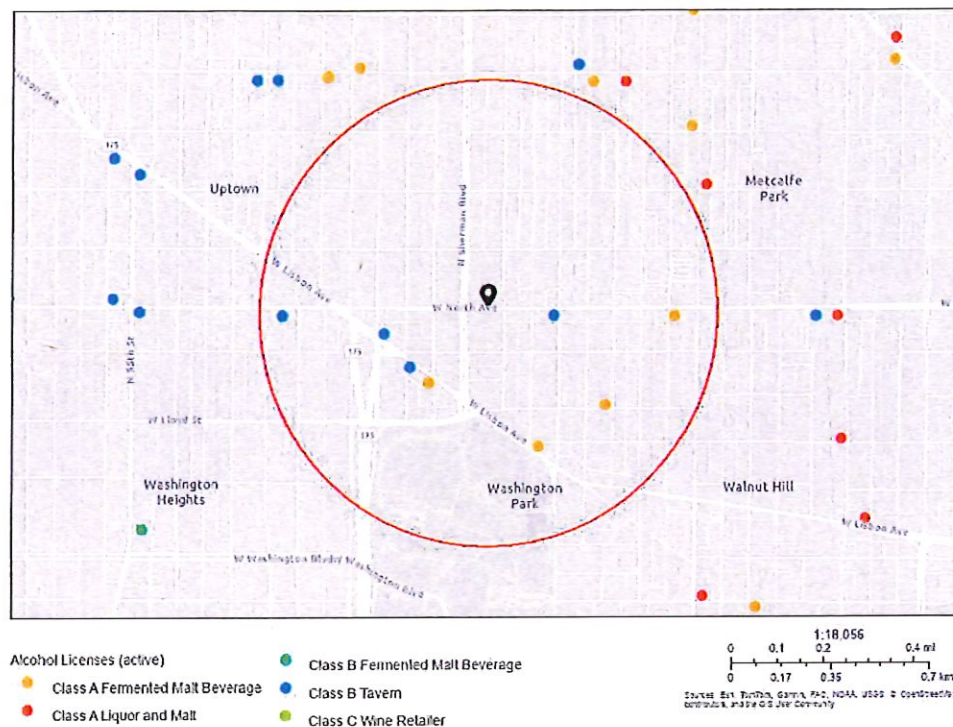


## Concentration Map for 4225 W North Ave

Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

---

## **Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:**

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.  
**Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.**
