Re: Estimate of Legal Fees for

Proposed City of Milwaukee, Wisconsin

Industrial Development Revenue Bond Financing

for Pettit National Ice Center, Inc.

Ladies and Gentlemen:

We have been advised that in the near future the governing body of the City of Milwaukee, Milwaukee County, Wisconsin (the "Municipality") will consider for adoption an initial resolution for an industrial development revenue bond financing pursuant to Section 66.1103 of the Wisconsin Statutes, as amended (the "Act") on behalf of Pettit National Ice Center, Inc. (the "Eligible Participant").

Section 10(g) of the Act requires that prior to the adoption of the initial resolution there be filed with your offices a document containing a good faith estimate of the legal fees which will be paid from bond proceeds. This letter is intended to be that document.

Estimating legal fees at this stage in the proceeding is difficult because many of the most significant factual matters considered by attorneys in determining their fees are not known with precision. The bonds have not as yet been authorized for issuance, and it is not yet definitively known how or to whom the bonds will be sold. The size and structure of the bond issue have not been finally determined. These and other matters are normally negotiated and determined after the initial resolution is adopted. As a result, the scope and amount of work which the various parties may choose to refer to their attorneys can vary considerably as the economic aspects of the financing are developed. However, based on experience in similar financings and on the assumption that the actual principal amount of the bond issue will be between \$1,800,000 and \$2,500,000, we estimate that approximately \$45,000 of legal fees may be paid from the proceeds of the bonds.

It should be noted that the Internal Revenue Code limits the amount of costs of issuance, including attorneys' fees, that may be paid from the proceeds of tax-exempt industrial development revenue bonds to 2% of the proceeds of the bonds. It is therefore likely that some, or perhaps all, of the legal fees associated with this bond financing will be paid from other sources.

The actual fees charged by the attorneys acting in the proposed bond financing may vary (perhaps considerably) from the estimate provided above. Without purporting to be exhaustive, the following are reasons why actual fees may be higher or lower than the estimate: (i) assumptions regarding the size, structure, complexity and timing of the bond financing may change; (ii) clients may alter the scope of their attorneys' engagements; (iii) parties may require legal opinions or legal advice beyond that normally requested in similar financings; and (iv) unforeseen legal problems may arise.

We are writing and filing this letter as an accommodation to the Eligible Participant and the Municipality to assist them in complying with requirements of Section 10(g) of the Act. We have not been authorized and do not purport to quote or commit fees on behalf of any particular attorneys.
