5. On 05/18/23, Milwaukee Police were dispatched to 3709 W Villard Av, for a shot spotter assignment. Officer spoke with the employee who stated that 3 subjects came to the location and took items without paying for them. An associate of the business stopped one of the suspects from taking items, and got into a verbal altercation. The suspects threaten to fight the associate of the store and employee heard three gun shots fired from outside. Officers located the associate of the business who explained that one of the suspects fired a hand gun outside the business and he left the location when he heard the gun shots.

6. On 07/28/23, Milwaukee Police were dispatched to 3709 W Villard Av, for a shooting. Upon arrival officers located a subject lying on the floor bleeding from gunshot wounds. The victim was transported to the hospital where he was later produced deceased by medical staff. Officers spoke with the gas station employee, who was one of the callers regarding the shooting. The employee stated that an argument took place between the victim and three subjects. Then one of the one the subjects shot the victim. All three suspects then ran from the location. The employee stated that he is contacting the IT person to access the cameras. Officers also spoke to the operator of the restaurant that is attached to the gas station. The operator stated that he saw three subjects hanging out by the gas station. From inside his business the operator heard guns shots and the same three subjects flee from the location. The operator provided video to the officers. The video provided the suspect's description, and the events of the shooting.

The listed items are regarding Milwaukee Police calls for service to 3709 W. Villard Ave.

7. On 07/29/24 at 900am., Milwaukee Police were dispatched to a Shooting. Investigation revealed a "security guard" confronted a subject who was stealing, an argument ensued, and the "security guard" discharged their firearm. The suspect sustained a gunshot wound to their leg, and was later arrested for warrants. The "security guard" was no longer on scene and employees stated they don't have the information on the "security guard". Employees stated the "security guard" makes their own hours and gets paid cash. The agent was later interviewed and stated the "security guard" is not an employee of the business and is not paid for their services. (2 reports)

8. On 04/16/25, at 10:50 a.m., an officer was dispatched to a Threat complaint. The caller stated a male was on the property selling items, and refusing to leave. The male was gone upon the officer's arrival.
9. On 05/12/25, at 10:49 a.m., officers were dispatched to a Shots Fired complaint. An employee stated two males were in the business engaged in a verbal argument. One male displayed a firearm and fired a round into the floor.
10. On 05/13/25, at 10:02 p.m., officers were dispatched to a Shooting complaint. A victim of a gunshot ran to the business where police were called. The employee was not able to access the security camera system during the investigation.
11. On 05/25/25 at 1200am., Milwaukee Police were dispatched to a Battery. Officers were advised a subject entered the store, came behind the desk and punched an employee. The employee stated they did not know what would have caused this to occur and did not want to press charges. The business was cooperative.

On Wednesday, June 11th, 2025, we were dispatched at 17:19 PM to investigate assist as a saturating squad for a robbery complaint in the area of 3709 W. Villard Ave, Hometown gas station, which is within the City and County of Milwaukee WI.

Squad 7240 with PO Duwan BECK and PO Marco MONTER went to the Hometown Gas station as the primary investigating squad. Squad 7240 was unable to locate the caller/ victim of this incident. The workers at the gas station did allow Squad 7240 to view camera surveillance footage for the incident.

Upon arriving at the area squad 7286 called over the radio that they believe they located the silver VW sedan described in the call for service as being the suspect vehicle, northbound on N 36th St from W Custer Ave. My partner and I then observed the vehicle and initiated a vehicle pursuit for reckless driving.

I did not review video surveillance footage. I did not go to the Hometown gas station, nor did I speak with any of the workers at the location during this incident.

I did not observe any violations in the licensed premise.

In previous investigations the staff at this location have been cooperative and have allowed immediate access to camera footage.

Singh advised that his English proficiency is limited and stated he did not wish to pursue a crime report at the time officers were on scene. Singh further stated he would notify his manager, who may contact police at a later time if they wish to file a report and provide surveillance footage.

SINGH reassured me that no battery had occurred at the incident address.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
