Our traffic engineering staff has investigated this request and found that a sight obstruction on the northeast corner of this intersection reduces the available safe approach speed. We, therefore, in the interest of public safety, recommend the installation of stop signs on West Chambers Street at North 81st Street.

We will prepare the necessary legislation for the next Public Safety Committee meeting, so that you may support it to final passage.

The Brewers Hill Association has worked with our staff to address traffic control changes in the area. After meeting on this issue, the following changes have been agreed to. Legislation will be prepared for the next Public Safety Committee meeting, so that you may support it to final passage.

- 1. North Palmer Street and East Vine Street remove east/west Stop, install north/south Stop.
- 2. West Vine Street and North 1st Street-remove north/south Yield, install east/west Stop.
- 3. North 2nd Street and West Vine Street remove east/west Stop, install north/south Stop.
- 4. North 1st Street and West Reservoir Avenue remove north/south Yield, install north/south Stop.
- 5. East Brown Street and North Hubbard Street remove north/south Stop, install east/west Stop.
- 6. West Brown Street and North 1st Street remove north/south Stop, install east/west Stop.
- 7. North 1st Street and West Lloyd Street remove north/south Yield, install north/south Stop.
- 8. North Hubbard Street and East Lloyd Street remove north/south Yield, install north/south Stop.
- 9. East Lloyd Street and North Buffum Street remove east/west Yield, install east/west Stop.
- 10. East Garfield Avenue and North Hubbard Street remove north/south Stop, install east/west Stop.
- 11. North 2nd Street and West Garfield Avenue remove east/west Stop, install north/south Stop.
