The officers observed 2 operating entertainment machines. The officer advised the applicant he could not operate the machines without a PEP license. He was advised to unplug the machines until he received a license. The applicant stated he understood and would comply.

The following items pertain to 1901 S. 35<sup>th</sup> St., Tiger Mart.

8. On 10/06/24 at 1:45p.m., Milwaukee Police were dispatched to an Armed Robbery. Investigation revealed two suspects approached the victim while they were pumping gas, displayed a firearm and demanded the victim's car. The suspects were unsuccessful and fled the scene. The business did not have an exterior video security system, however, stated one suspect was inside earlier and they would have video of the suspect once a manager was on scene. The business was cooperative.

9. On 01/02/25, at 8:45 p.m., Milwaukee Police received a Vehicle Theft complaint. At 8:40 p.m., the victim parked his vehicle on the west side of the gas station, ran inside "quickly", and when he returned outside his vehicle was gone. Officers conducted follow up at the business, but there were no exterior cameras at the location that could have captured the theft.
10. On 05/25/25 at 12:26a.m., Milwaukee Police were dispatched to a Shooting complaint. Officers observed seven spent casings in the front entrance and two inside the gas station. The employee stated the suspect was making a purchase, when the victim entered, and punched the suspect in the face. At that time, the suspect pulled out a firearm and began to discharge their firearm. The business was cooperative, however, while viewing video the gas station lost power causing video of the incident to be lost.
11. On 06/19/25, at 8:55 a.m., officers were dispatched to a Property Damage complaint. An unknown driver struck a gas pump causing approximately \$15,000 in damage.

On Sunday, October 06 ,2024 at 1:45PM, I was dispatched to 1901 S. 35th St. for an armed robbery complaint.

Upon arrival, I spoke with the victim who stated he was pumping gas at the listed location and was exiting the gas station returning to his vehicle. The victim stated he observed suspect 1 and suspect 2 standing in the southwest corner of the lot as he was exiting. The victim stated he was pumping gas and both suspects approached him and demanded his items. The victim stated the suspect 1 brandished a chrome handgun from his waist band and stated "give me your car keys". The victim backed away from the suspects and both suspects attempted to forcibly takes his keys from the victim. The victim stated this caused his shirt to rip, bag of chips to scatter on the floor, and the victim sustained scratches on his chest.

The suspects were unsuccessful and fled eastbound on W. Burnham St.

The victim then notified police of what occurred,

There are no exterior cameras on the gas station but there are interior cameras. P.O. AL-ZALLOUM spoke with the gas station attendant who stated one of the suspects entered the gas station prior to this incident occurring. Unable to access cameras today due to manager not working today.

POSSIBLY related to armed robbery carjacking on 1937 S. 37th St. in which vehicle was taken. Two suspects matching the description in both robbery incidents.

On Thursday, January 2, 2025, I P.O. ALANIZ, was assigned to front desk, spoke to Christopher SCHMITZ (W/M 04/28/1986) who was at the address of 1901 S. 35th St (Located in the City and County of Milwaukee, WI) and his vehicle was stolen from the location.

SCHMITZ stated he was travelling northbound on S. 35th St from W. Rogers St, when he observed the Citco Gas Station (listed address above.) SCHMITZ stated he parked the vehicle on the side of the gas station (West Side), ran inside "quickly" and when he came back outside his vehicle was gone. SCHMITZ was in possession of the key, due to the vehicle being a push to start vehicle. SCHMITZ did not observe anything out of the ordinary upon entry to the location.

SCHMITZ stated the theft occurred around 8:40 PM. Squad 2220 (P.O. Mariolys NELSON and P.O. Daniel LUKASIK) conducted follow up at the listed address above, and there were no exterior cameras at the location that could have captured the theft occur.

SCHMITZ has both WI registration plated affixed to the vehicle (AVY-9730), all keys are accounted for, the title is through a lien company of "Bridge Crest" and there were no items of apparent value. This report is written by Police Officer Alonso ESPINOSA, assigned to District Two, Late shift, Squad 2320, along with my squad partner Police Officer Diego Kilwein.

On Sunday, May, 25,2025 at approximately 12:26am , my partner and I were dispatched to 1901 S. 35th St., to locate a scene for a walk in shooting into St. Lukes.

Upon our arrival, we observed seven spent casings in the front entrance by the door of the gas station and two spent casings inside of the gas station .

I spoke to the clerk who is employed by Tiger Mart Gas Station, identified as Rajan SINGH (A/M 03/06/1992). He stated a black male was purchasing cigarettes, when a white male entered the gas station. SINGH stated the white male then struck the black male in the face and then white male began to exit the gas station. SINGH stated the black male reached into his waist for a firearm and began to discharge the firearm towards the white male that exited the gas station.

The business was cooperative with the investigation. While trying to view video surveillance footage. SINGH stated that gas station lost power and that the video surveillance system reset and did not capture any of the incident. Video surveillance begins to capture shortly after we arrive on scene at approximately 12:31AM.

I reviewed video surveillance footage at the gas station. There was no video captured for the time of the shooting incident. The video surveillance timestamp showed the year being 1970.

On Thursday, June 19th, 2025, at approximately 8:55 AM, I was assigned to Squad# 2130 with P.O. BOOTH and were dispatched to investigate a Criminal Damage to Property at the address of 1901 S. 35th St., which is in the City of Milwaukee.

Upon arrival at the location, I spoke with the caller/owner Amardeep KHEHRA (A/M, 12/12/85), who stated that on the listed date at approximately 1:00 AM, an unknown subject approached his clerk (Raja Multani) attending the gas station and advised him that he noticed one of the gas station pumps had been struck by a vehicle. The subject stated that he had not observed the vehicle, he just noticed the damage to the pump.

According to the KHEHRA, the damage to the pump is estimated at approximately \$15,000 dollars in U.S. currency to repair or replace. He further stated that the insurance company for the station is AUTO OWNERS INSURANCE.

There were no witnesses to the listed incident on-scene and we were unable to retrieve any video evidence to identify a vehicle.

Nothing further to report at this time. PV-17 issued. Case pending.

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
