Strategic Plan Compatibility Statement:	Goal 6 The district is accountable for measurable results
Summary:	The Administration is requesting authority for the Board's President and the Superintendent to complete the sale of the building located at 2760 North 1st Street in accordance with the attached, revised term sheet. The revised term sheet, drafted by the Office of the City Attorney and the Department of City Development, outlines the parameters to be used in negotiating and executing the sale of the property. Use of a revised term sheet allows the district to complete real estate transactions in the most expeditious manner. This method has been used in the past and has been recommended by the City Attorney's Office.
	Pursuant to Wisconsin Stats., § 119.60(2), property used for school purposes shall be sold by the City upon written request of the Board of School Directors. Sale of district real estate requires the Common Council's approval. Following approval by the Board of this proposed sale, the Administration will submit the revised sale request for the City's approval.
	The Administration requests a closed session for the purpose of considering a negotiating strategy for the possible lease or sale of public property located at 2760 N. 1st Street (the former Malcolm X Academy).
8	This request is made pursuant to Wisconsin Statutes, Section 19.85(1)(e), which allows a governing body to go into closed session for the purpose of deliberating or negotiating the purchasing of public properties, the investing of public funds, or conducting other specified public business, whenever competitive or bargaining reasons require a closed session.
	The Board may reconvene in open session to take action on matters considered in executive session; otherwise the Board will adjourn from executive session.
	No public testimony will be taken at this meeting.
