The Milwaukee Metropolitan Drug Enforcement Grant (MMDEG) aligns with the city-wide strategy to reduce crime and enhance quality of life by reducing the volume of controlled substances in the Milwaukee area. The funds for this grant will be utilized to partially fund salaries for one Sergeant and two Police Officers assigned to MPD. Funds for task forces are provided by DOJ headquarters through the Wisconsin Office of Justice Assistance and the Milwaukee County District Attorney's Office. The primary purpose of the task force is to interrupt illegal drug trafficking through intelligence gathering and undercover operations. The efforts made from this task force will assist and lead to successful prosecutions at state and federal levels.
