

Alderman Perez -

Per our conversation on Friday 9/6/19. There has been a male thief that has been stealing red bull from for around over a year. This person stole around 14 – 20 cans of redbull by filling up his jacket and than leaving the store. This occurred at 10:50 am on 9/6/19. I happened to pull up to the store as he was leaving. I spoke with the manager on duty and she said he just stole redbull. You can tell his jacket had product in it. I than proceeded to follow him to see what he was going to do with this merchandise. He rode his bike behind the strip mall by the Target on Chase avenue. He took the redbull out of his jacket and into a white plastic bag. I than followed him to the OG Mini Mart located on 16<sup>th</sup> and Becher. The male took the cans of redbull into the store. He was in the store for 3-5 minutes and than left with out the white bag and redbull and than proceeded to ride his bike away. I did not get the Officers name that I spoke with and took down the information at District 2. I was there around 11am and he was a white male officer early 30's. Let me know if you need anything further. I hope this helps to stop this illegal activity. Photos of the thief and the OG Mini mart are included.

- 2. On 09/09/19 Milwaukee Police conducted a License Premise check at OG Mini Mart, located at 2121 S. 16th St., regarding information received they were purchasing stolen merchandise. Officers had knowledge that a suspect was stealing multiple cans of Red Bull from Speedway (369 E. Oklahoma Av), then entering OG Mini Mart with the stolen merchandise in a plastic bag and exiting the store minutes later empty handed. Officers interviewed the agent (Aman GEBREZGABIHER) who denied purchasing stolen items. Officers did observe a large amount of Red Bull in a rear storage area, some of which were in plastic bags; however, GEBREZGABIHER stated that was stock left from the previous owner. GEBREZGABIHER was asked to show officers surveillance video, however, he stated he would need to try to obtain the password for the surveillance system from the previous owner.
- 3. On 09/16/19 Milwaukee Police conducted a License Premise check at OG Mini Mart, located at 2121 S. 16th St., along with Agent Georgeanne KING, Department of Revenue Alcohol and Tobacco. Officers observed multiple bottles of tequila in the rear storage room. Since this establishment does not have a Class A Liquor License, Agent KING confiscated all bottles of alcohol.

4. On 11-9-19 a 16 year old youth working in conjunction with the Milwaukee Police Department and Wisconsin WINS Youth Tobacco Initiative entered the OG Mini Mart and was able to purchase a Peach Flavored Swisher Sweet Cigar from the clerk. The clerk admitted to the sale and apologized.

This Report is being submitted by PO Xavier BENITEZ assigned to License Investigation Unit. On Tuesday September 9th, 2019 at 11:12 am PO Penny MONREAL and I conducted a license premise check at O.G. Mini Mart, located at 2121 S. 16th St. I was equipped with an Axon worn body camera at the time of the premise check. To view the interaction in its entirely please review Axon camera footage.

Upon arrival I spoke with the licensed agent on scene, Aman Y. GEBREZGABIHER (m/u 03-05-95) who stated that he usually runs the store during normal business hours. GEBREZGABIHER stated that he was working the store on 09-06-19 all day. I explained to GEBREZGABIHER, that officers where at the location to perform a license premises check and, to investigate complaints of stolen Red Bull drinks possibly being purchased at the establishment. GEBREZGABIHER stated that he does not purchase any Redbulls from outside people coming to the store, and he mentioned that he does not even sell that many Redbulls as a whole.

I explained to GEBREZGABIHER that officers had knowledge that on 09-06-19 approximately 11:00 am an individual described as a male, unknown race, med brown complexion, with short cropped med black hair, black beard, last seen wearing a gray jacket with black sleeves, black pants, black shoes, last seen on a red in color bicycle, came in to the store with a white plastic bag of 14-15 RedBulls. The subject was in the store for approximately 5 mins and left the store without the white plastic bag. I then proceed to show GEBREZGABIHER a still photo of the described subject. GEBREZGABIHER stated that he did not recall the subject coming into the store. PO MONREAL observed cameras in the establishment and, asked GEBREZGABIHER if officers could review footage from that day.

GEBREZGABIHER then stated to officers that he can not access his cameras because the previous owner has the computer passwords, and that he can only access video footage from his cell phone from 24 hours prior. GEBREZGABIHER stated he has been the current owner for approximately four months. GEBREZGABIHER stated that he currently was not able to talk to the previous owner but will call him tomorrow for the password. PO MONREAL walked around the premises while I spoke with GEBREZGABIHER, regarding how I believed he was not being very forth coming with the video footage. GEBREZGABIHER then became irritated and asked, why is your partner walking around my store? I explained to GEBREZGABIHER that officers have the legal right to check the whole establishment as to regards to his license for the business. In the back area of the store officers observed an abundance of RedBulls, in crates and some in a plastic bag. GEBREZGABIHER immediately stated that the items was stock from the previous owner.

I gave GEBREZGABIHER my contact information and he stated he would contact me if the described comes to his store, or if he gets access to his cameras.



On Monday, 09/16/19 at 12:56p.m., PO Xavier BENITEZ and I conducted a license premise check at OG Mini Mart, located at 2121 S. 16th St., along with Georgeanne KING, Wisconsin Department of Revenue Alcohol and Tobacco Agent. Officers introduced ourselves to the agent: Aman Y. GEBREZGABIHER, who was the sole employee on scene. As Agent KING was reviewing tobacco inventory and invoices, I was checking for any other violations on the premise. In a back storage room I observed 3 bottles of tequila (various brands) on the shelf, as well as two bottles of tequila in a cooler. Since this establishment does not have a Class A Liquor License, Agent KING confiscated all five bottles and advised GEBREZGABIHER of the violation. GEBREZGABIHER stated they were for personal use. Agent KING advised GEBREZGABIHER that since he did not possess the proper license, he could not have any alcohol on the premise, even if it were for personal use. No further violations were found.

Assisting in this assignment was: Carlos VILLAVALADEZ H/M 05/20/03 2719 W. Cherry St. Milwaukee, WI 53208. VILLAVALADEZ is 16 years old and not of legal age to purchase tobacco. Further assisting with the assignment as the observer was: Janiya J. HARLEY B/F 03/05/02 2403 W. Oklahoma Av.

At approximately 11:25A VILLAVALADEZ entered O.G. Mini Mart, located at 2121 S. 16th St., and purchased a Peach flavored Swisher Sweet Cigar. VILLAVALADEZ stated the cashier did check his ID, however, sold to him despite this. VILLAVALADEZ described the cashier as: A/M wearing a burgundy hooded sweater and jean jacket. Upon entering the store I was able to immediately identify the cashier based on the description provided. The cashier was identified as: Tesfenkieal GEBRE A/M 01/01/94 4401 N. 84th St. Milwaukee, WI 53225. TESFENKIEAL admitted to the sale and apologized stating he thought it was a fake ID. I explained I would be issuing a citation for the violation to the listed agent.

Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished:
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
