Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should request an interpreter attend the meeting with you, at your expense, so that you can answer questions and participate in your hearing.

This report is written by Police Officer Xavier Benitez, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 06/23/20 at 1 1 :00am, Milwaukee Police conducted follow up to a complaint on a mobile food truck, Mr. Taco, which was parked at 1831 E. North Av. The complaint was regarding parking restriction concerns of the food truck., from surrounding businesses. Officers spoke with the agent and wife on scene, who stated that they thought they were fine as long as they paid the parking meter. The agent was given a copy of city ordinance 1 15-45 as it pertains to mobile food trucks, and explained the parking restrictions with in. The agent stated that they understood the parking rules and would comply.
2. On 07/28/20 at 12:00pm, Milwaukee Police conducted a License Premise check on a mobile food truck, Mr. Taco parked at 1831 E. North Av. Officers spoke with the agent and wife with continued concerns from surrounding businesses of parking issues, littering, and the area businesses being used for Grub Hub orders. The agent stated that they do move to different locations, and they tell customers to not park in business lots, and they don't use Grub Hub for delivery orders. The agent stated that they were trying to use a nearby private lot to help remedy parking issues.

Officers from District 1 will be monitoring the ongoing issues as they were occurring on 2<sup>nd</sup> shift hours.

3. On 09/18/20 at 6:58pm, Milwaukee Police were dispatched to 200 E. Knapp St regarding a trouble with subject complaint. Officers spoke with the owner of Fatty Patty, who stated that the mobile food truck, Mr. Taco was parking in his spot. Officers informed both parties they have to follow the proper parking rules and that no spot is assigned to a mobile food vendor. They were also informed to keep a moderate distance from one another due to safety concerns of large groups gathering on the weekend. Officers reviewed the food licenses of both businesses, Mr. Taco was current on the license, and Fatty Patty had an expired state license. The agent of Fatty Patty was advised regarding the expired license.
4. On 01/22/21 at 6:03pm, a Milwaukee Police Officer of District 1, took a phone complaint regarding mobile food truck, Mr. Taco parking at a location longer than two hours. The desk officer, had police officers follow up on the complaint. Officers spoke with the caller who showed officers time stamped photos of Mr. Taco parked at 2921 N. Oakland Av, over two hours. The agent was given a verbal warning, regarding the same issue on 01/21/21 by officers. The agent of the food truck was issued a citation regarding the violation.

5. On 11/02/21 at 3:20am, Milwaukee Police took a threat complaint at District 1. The victim who operates a mobile food truck, Mr. Taco stated that a disgruntle customer made threats to harm staff with a gun. The operator was cooperative with the investigation and provided video. The suspect was later arrested for his actions.

This report was written by P.O. Brian LaROQUE, assigned to District One, Late Shift.

On 11/8/2021 I did speak with Vanessa (NMN) MOLINA (W/F, 6/24/83) who was identified as the representative for Mr Taco Food Truck.

Contact was made with the license premise after a customer became upset with his food order and threatened the staff of Mr Taco Food Truck with a firearm. MOLINA cooperated with the investigation and attempted to remove herself and her employees from the situation but was followed by the disgruntled customer.

For safety reasons MOLINA drove her food truck directly to District One to report the incident where the disgruntled customer was later arrested for his actions. MOLINA provided officers access to her security camera system and forwarded copies of the video to the police department in a timely manner.

The licenses for the business were properly posted and no violations were observed during this incident.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

## Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

**Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.**
