There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.


I understand that Jetz #4524, GPM Southeast LLC, located as 1425 N. Farwell Ave., is up for license renewal and I would like to register concerns with this business.


Concerns:

- I walk by this business on a near daily basis, and as seen in the attached photos, this garbage and crates strewn about seems to be standard operating procedure for ownership. This has been a regular scene here for well over a year. This business is an embarrassment to the neighborhood and I question whether they should even be in business if they cannot manage simple tasks like keeping their property clean. Owners, managers and employees have zero pride.
- —The only time I've seen employees outside is when they are smoking cigarettes near the entry doors (which is likes 12 feet from gas pumps).
- —Also, this past winter I submitted multiple service requests for them failing to shovel sidewalks and/or icy sidewalks.

If license gets renewed, there should be firm stipulations and regular inspections.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 12/31/19 at 2:00pm, Milwaukee Police were dispatched to 1425 N Farwell Ave, for a theft complaint. Police spoke with the manager who stated that a subject ran into the store and grabbed a large amount of items. The suspect then fled without paying for items. The suspect then fled in an occupied silver vehicle that was parked near the location. Officer reviewed the video and obtained the suspect vehicle plate and conducted follow up with the registered owner. The business was cooperative with the investigation.

2. On at 04/15/23 at 12:35pm Milwaukee Police were working the Wisconsin Wins Tobacco Initiative and had an underage minor enter 1425 N. Farwell Av in attempt to purchase tobacco products. The clerk, identified as Spain, Diamond L sold a pack of Newport cigarettes to the 17 year old student without asking for ID. Officers spoke with the clerk regarding failing the compliance check, and that she sold to a minor.

This report is written by PO Raul ORNELAS, assigned to District 7, Early Power Shift, MCORP Unit.

On Saturday, April 15th, 2023, at approximately 12:35 PM, Squad 7263 (myself) and two Public Safety Cadets (Tegan E. SCHMITZ, W/F, 06-05-2005 (17 yrs old), and Alejandrina PARTIDA-HERNANDEZ, W/H/F, 08-28-2005 (17 yrs old) conducted a compliance check at 1425 N Farwell Ave (Jetz Gas Station) located in the City and County of Milwaukee. This was in partnership with the Memorandum of Understanding with Gemmunity Advocates, Coalition Coordinator the City of Milwaukee Tobacco-Free Alliance, Charlie Leonard. Wisconsin Wins Campaign (WI WINS is an intervention program designed to help the State of Wisconsin come into and stay in compliance with requirements of the federal Synar Regulations. The two teens were trained in the WI WINS program protocol Saturday, April 11, 2023.

PARTIDA-HERNANDEZ and SCHMITZ entered the Jetz Gas Station attempting to purchase products for sale, not intended for minors. The goal was for the organization to request identification and turn the minors away after they find out both were teens and ineligible for the sale. PARTIDA-HERNANDEZ requested the sale of a Newport Box of cigarettes from the cashier later identified as Diamond L. SPAIN (B/F, 09-02-1999). SPAIN provided PARTIDA-HERNANDEZ with the box of Newport cigarettes' and did not request identification at all. PARTIDA-HERNANDEZ paid cash and completed the sale. No receipt was given to PARTIDA-HERNANDEZ. PARTIDA-HERNANDEZ returned to the meeting point and provided me with the description of the encounter and the product of sale.

I then returned to Jetz Gas Station and spoke with SPAIN who was the only employee working at the time. SPAIN stated she was the Assistant Manager at this location. SPAIN provided the License for the location which was hanging on the wall which is as follows:

I then advised SPAIN on the investigation and told her that she sold a tobacco product to a minor. I informed her that a citation will be issued at a later date for the violation and that a License Premise

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place on 10/17/2023 at 1:20 PM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel — Channel 25 on Spectrum Cable — or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
