This license report is submitted by Police Officer Chauncey HARRIS assigned to District 5 Early Power Shift. On Sunday, 4-23-2023 at approximately 6:22pm a caller reported a shooting at 401 E. Capitol Dr. (Walmart). The caller stated an unknown subject shot herself in the foot inside the bathroom. Upon arrival officers located an injured female inside the public bathroom located toward the rear of the store. The female had a gunshot wound to her left leg and was bleeding profusely laying on the floor. Further investigation by officers after reviewing interior camera footage revealed the female entered the restroom with an additional female and a small child. There was a Walmart employee in the restroom at the time of the incident that willingly cooperated with officers. The employee informed officers they did not suspect anyone known or unknown to the female intentionally injured her. The employee observed the female enter a toilet stall alone and shortly after the associate heard a single gunshot and observed the female exit the stall laying on the floor bleeding.

I was assisted with the investigation by Loss Prevention Officer Tyree DOSS. DOSS allowed officers to view the interior and exterior cameras to identify additional subjects involved with the injured female. To my knowledge the store manager MOON was not on duty at the time of the investigation. DOSS informed the shift manager of the incident.

Upon arrival, we spoke to the Sup031435ervisor of Walmart Loss Prevention identified as Lakesia D BELL (F/B 09/20/1982).

#### Interview with Lakesia BELL

BELL stated at approximately 6:44 AM an unidentified black male with shoulder length dreads, wearing a black sweatshirt with an orange design on the front, black sweatpants and gray crocs later identified as Jakobe L WILLIS (M/B 06/26/2001) entered Walmart and grabbed a plastic grocery bag by the checkout aisles. BELL stated WILLIS then walks toward the diaper section and puts two packs of Pampers Cruiser 360, size 4, 21 count into the grocery bag. BELL stated she walked toward WILLIS and confronts him regarding her observations. BELL stated WILLIS ignores her. BELL stated she attempts to grab the bag from WILLIS. Bell stated WILLIS lunges away and one pack of the Pampers Cruisers falls out onto the floor. BELL stated WILLIS then walks toward the exit in an attempt to avoid her. Bell stated she attempts to follow WILLIS and get the last product back. BELL stated she observes WILLIS to motion toward his right sweatshirt pocket and observes WILLIS to be clutching the handle of a black firearm, causing her to fear for her life. BELL stated she then tells WILLIS to have a good day and returns back to her office. BELL stated WILLIS never says a word to her. BELL stated when she returned to the office she observes WILLIS flee the location in 2009 Chevrolet Cobalt, bearing WI Plate#ANT4023. WILLIS was last seen driving westbound on E Capitol Dr.

#### Video Observation

I watched the camera footage of the whole incident. I observed WILLIS enter Walmart through the west entrance at 6:44AM. WILLIS walked to the check out and grabbed a gray plastic grocery bag. WILLIS then walked to the diaper section and put two packs of Pampers Cruisers 360 in the plastic grocery bag. BELL walks up to WILLIS to confront him. WILLIS avoids BELL and walks a different direction. BELL then meets WILLIS at the west entrance of Walmart. BELL attempts to grab the plastic grocery bag from WILLIS. When BELL attempts to grab the plastic bag one of the packs of Pampers Cruisers falls out of the bag. As WILLIS is exiting the Walmart at 6:48AM he has his right hand on what appeared to be a black firearm that was concealed in his sweatshirt pocket. WILLIS then gets into a 2009 Chevrolet Cobalt, bearing WI Plate#ANT4023. WILLIS then exits west on Capitol Dr.

Upon arrival, I observed a large supermarket style store with a large parking lot directly north of the store. The store is constructed mostly of white//blue/brown painted bricks and cements blocks. The store could be better described as having two main entry points on the northern front of the store. Above these two sets of doors is the word "WALMART" prominently displayed in massive white letters along with a yellow star like logo. (This described display is consistent with the trademarked Walmart

logo). The numbers "401" are prominently displayed in white immediately to the left of the word "WALMART." Furthermore, above the easternmost public doors are the words "HOME & PHARMACY" in large white letters. Above the westernmost doors is the word "GROCERY" in white letters. There are public access points to the parking lot on the west side (North Richards St), north side (East Capitol Drive), and east side (North Holton Street). At the time of the call, the parking lot was moderately full and customers were coming and going as if all was fine despite the criminal activity which had just occurred. Unfortunately, there were multiple vehicles violating the no stopping/parking signs and blocking multiple crosswalks/emergency parking locations in front of the store which made it difficult to safely traverse the parking lot.

I entered into the easternmost doors because, based on my training and experience, I knew that the loss prevention office was in the vestibule inside of this doorway. The door to the loss prevention office is inside of the vestibule and faces west. The door, which was gray, was locked and the words "authorized personnel only" are displayed on a navy-blue sticker on the door.

I was unable to speak to the caller, NATHANIEL R. JOHNSON (01/16/1986) as he had left work for the day already. I was informed that JOHNSON is a loss prevention specialist at this Walmart location. A phone number was left for JOHNSON which was 414-967-7804. There were multiple other members of the loss prevention team who were inside the loss prevention office.

To the best of my recollection there were 3-4 loss prevention officers inside the office. I did not see any weapons on their persons. I was unaware of any armed security personnel who were at the store during the incident.

Because the complainant was no longer on scene, I did not review surveillance video. It should be noted, I was not denied access to the video, nor was I allowed access to the video since I did not request it. Because of this fact, I did not apply for a search warrant to seize any video surveillance at this time. This does not mean I may not in the future request a search warrant for this video if the need arises.

While on scene, I did not observe any licenses posted, but that may be due to the fact that I was not searching for any. I did not observe any violations in the licensed premise.




