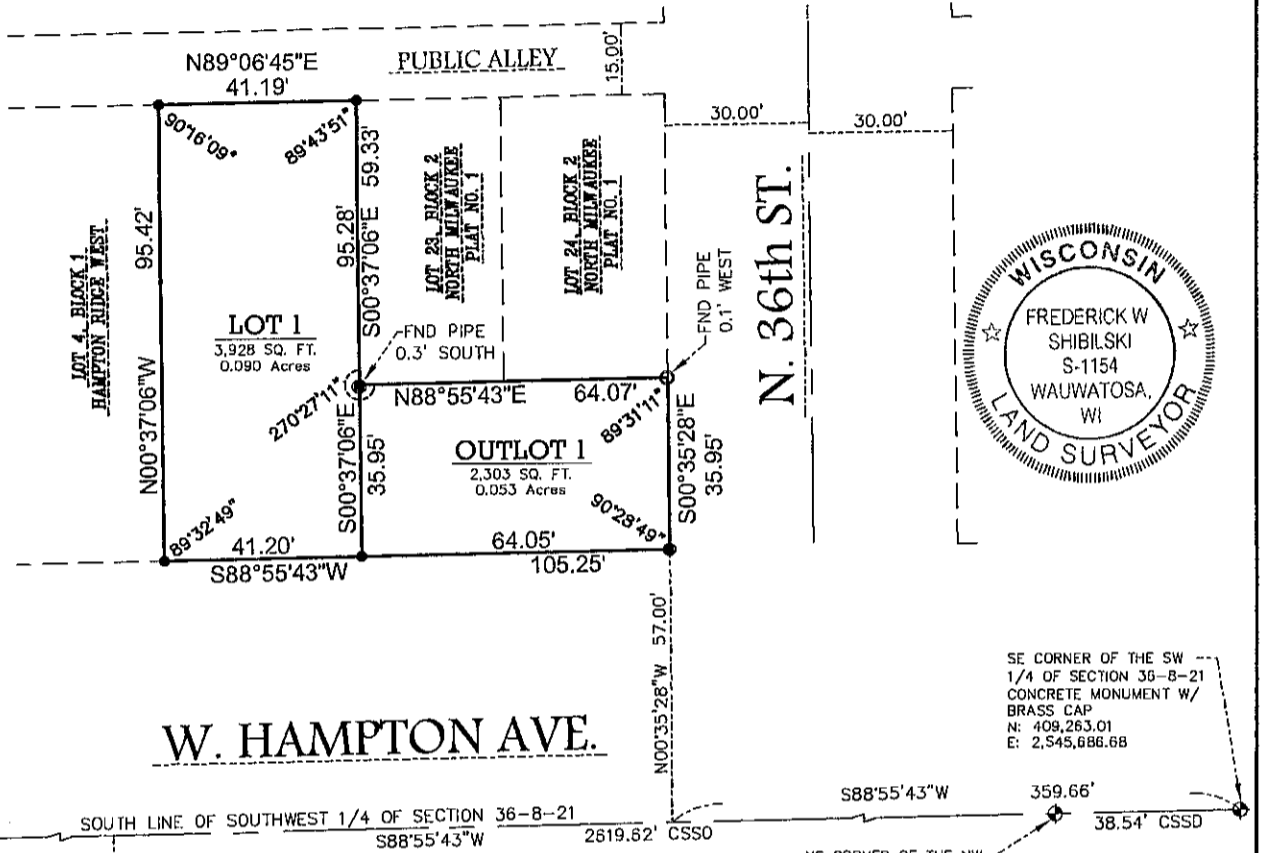

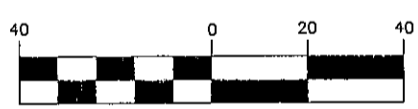


SE CORNER OF THE SW 1/4 OF SECTION 36-8-21

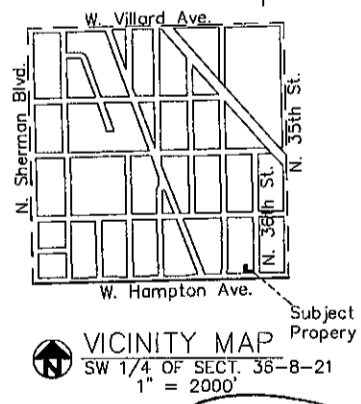
SW CORNER OF THE SW 1/4 OF SECTION 36-8-21

I, Frederick W. Shibilski, a registered land surveyor do hereby certify:

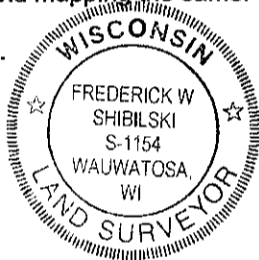

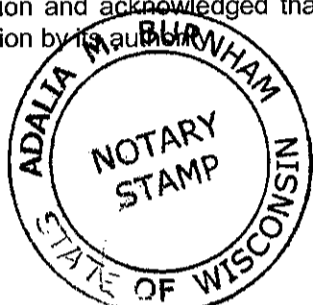
