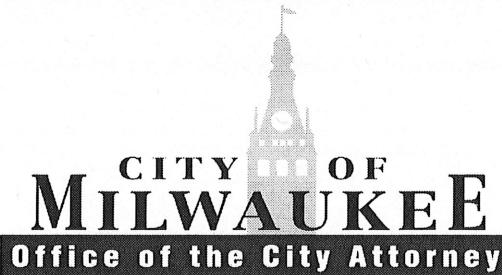


Enclosed please find a proposed resolution. We ask that it be introduced and referred to the Committee on Judiciary & Legislation, with the following recommendation.

On August 1, 2017, Street Maintenance crews replaced a sidewalk at 2635 South Kinnickinnic Avenue. On September 12, 2017, the City received notice that the crew had splattered concrete on the façade of property at 2365 South Kinnickinnic Avenue. A crew attempted to clean the façade, but the panels were further damaged during the cleaning process. The panels are made of a wood veneer and are unable to be repaired.

Because settlement of this matter is deemed expeditious to the City of Milwaukee, we recommend settlement of the claim in the amount of \$5,948.95 and have enclosed an appropriate resolution for your convenience.
