As this creates a new due process hearing about food-peddler *spaces* it may be subject to the same scrutiny as our current hearings. This does not make them illegal but can and likely will add to the work in the LI committee and subjects these committee determinations to certiorari actions which will be handled by the CAO.

As with any proceeding in front of the LI committee, a robust record supporting any disciplinary action is required.

Additionally, this new penalty structure may itself be challenged (which could test the robustness of the existing food truck legislation). The legal advocacy firm WILL has previously indicated it is paying increased attention to our food truck legislation. As there was no penalty associated nor any previous method to evict there was no adverse action made under the existing scheme. This changes that and again could subject the whole structure to judicial scrutiny.

Again this is not illegal under our current understanding.
