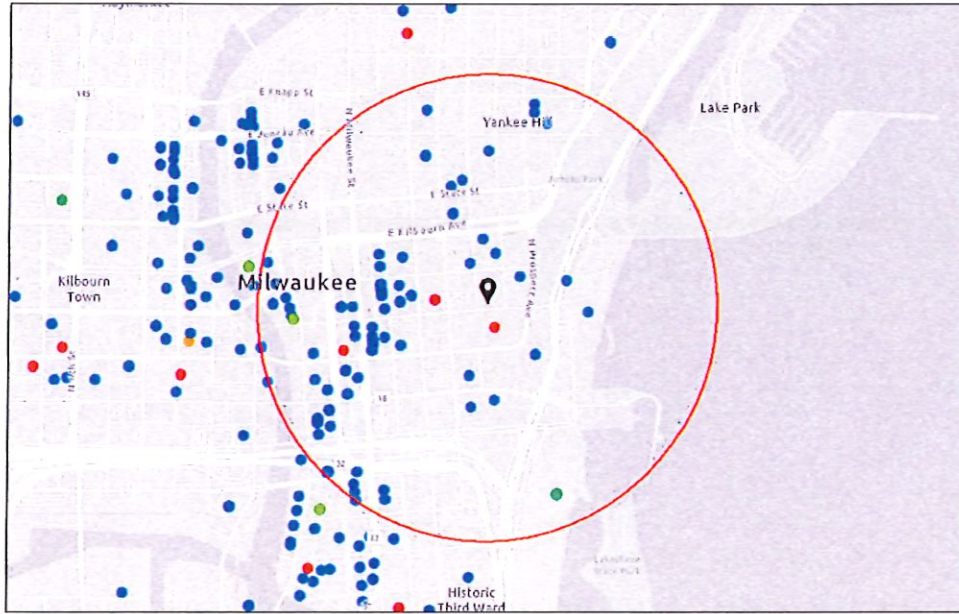


Concentration Map for 814 E Mason St

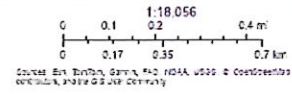

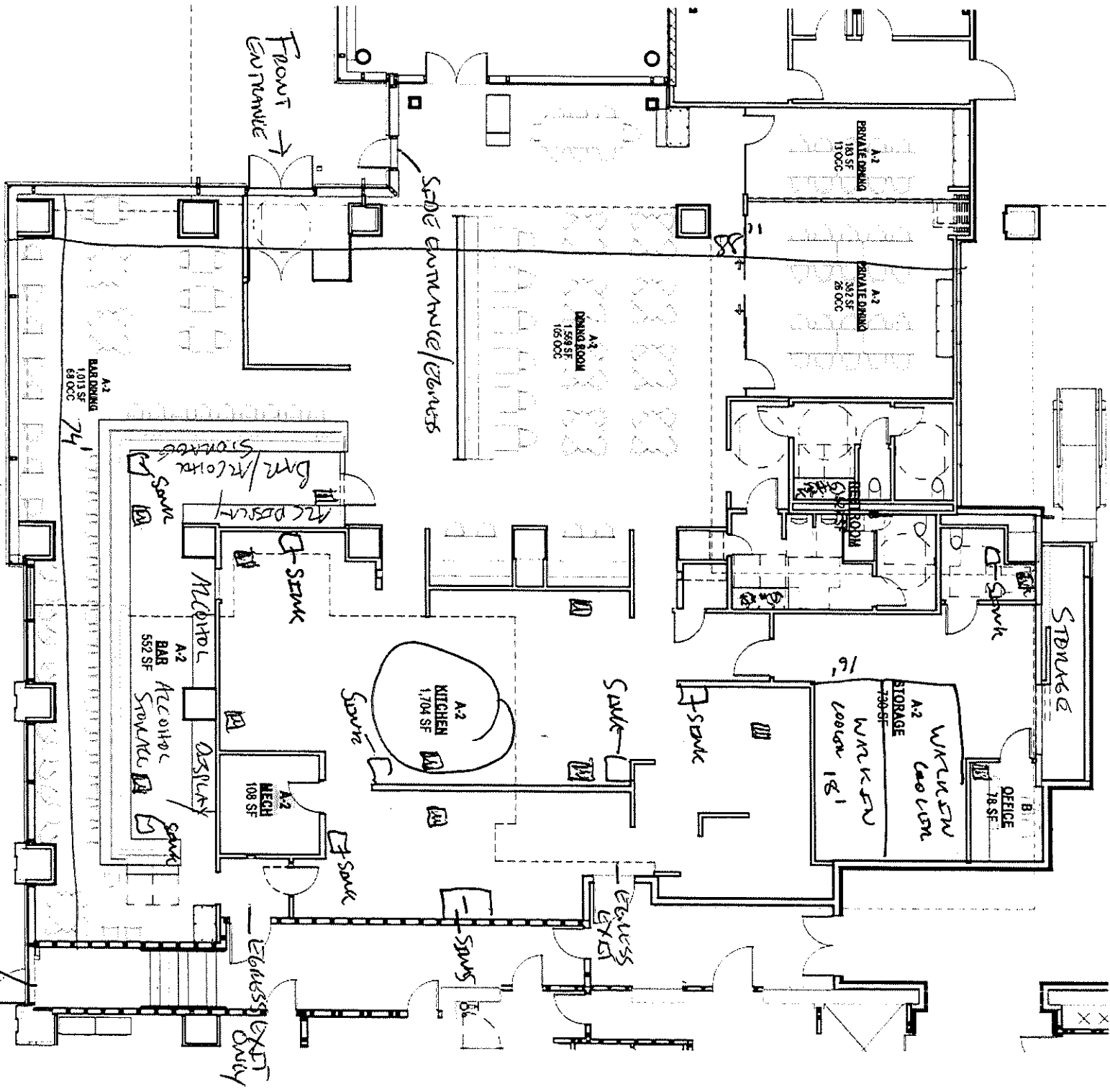
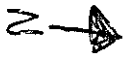
