Dear Mr. Kmichik:

We have received your claim in the amount of \$1,034.99, relating to damage allegedly sustained to your vehicle rims and tire on December 16, 2004 when it was towed to the City of Milwaukee Tow Lot.

Our investigation reveals that your vehicle was towed on December 16, 2004. The PT-27 form, completed prior to the tow, and the Tow Lot Vehicle Inventory Form, completed upon arrival at the tow lot and release from the tow lot, have no damages listed. The vehicle was released to you without incident. You came back to file a complaint after it was released. The damages claimed would not be caused as a result of typical towing or storage of a vehicle. As such, the City cannot accept liability. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
