There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; thef; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the license and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

Dear Mr. Cooney:

We would like to add our voice to the conversation regarding non-renewal of the license for Old Times Sake MKE LLC, 2221 North Humboldt Avenue. My neighbors and I have documented the numerous problems we have experienced with this establishment since it was granted a license in 2024. We have reported numerous violations of the original application, amended plan, actual license and follow-up meetings' assurances made by the owner, Mr. Simms. The MPD, Alder Coggs, your office and, of course, Mr. Simms are well aware of the negative impact his business is having on the neighborhood – one as recently as an incident on the weekend of April 5th.

We note with concern that Mr. Simms is now asking to renew the license for 2221 North Humboldt as Vision Sports Bar and Grille. Does that mean there will be even bigger crowds with more noise on Garfield and Weil; does this mean the illegal (?) food truck will be replaced with food service potentially adding even more litter to the neighborhood; does this mean even more amplified noise already caused by the jukebox, karaoke, TVs, bands and acts; and, will this mean he can continue to operate in a manner that flaunts the very assurances he has given to be a good neighbor, as codified in the current license, his application, the amended plan and assurances given to Alder Coggs and the residents of the neighborhood?

We moved to Weil Street 5 years ago. We have endured at least 3 bar operations at 2221 North Humboldt Avenue. By far, SNL and Mr. Simms and his unruly patrons have been the rudest, most untrustworthy and selfish of all the predecessor establishments. He hasn't taken his responsibilities to the neighborhood or on the license seriously, and I doubt he has any intentions to do so in the future - *as SNL* or Vision. I wholeheartedly support a decision to revoke his license and to not renew the location as Vision Sports Bar and Grille.

On 05-07-25 Jimmy SIMMS, the agent of Visions Sports Bar and Grill walked into District 5. I spoke to him and he wanted to know if I could come to the bar, in order to look/listen to his speakers. Visions Sports Bar and Grill is a licensed premise, located at 2221 N. Humboldt Ave., in the city and county of Milwaukee. I informed him that I could meet on 05-08-25 at noon.

On 05-08-25 shortly after 12:00 p.m., I met with SIMMS and we began to talk about the noise that the neighbors were calling in about. The location is set to have a meeting about his license on May 16th 2025.

SIMMS showed me where his speakers are located throughout the bar. There are 4 speakers across from the main bar, two are connected to the Jukebox system and the other two are controlled with his cell phone. These speakers face the bar. In the back area, where he has televisions and tables with stools set up there 4 speakers, two smaller speakers and two larger speakers. The smaller speakers face the back doors, which leads outside to the back patio, while the big speakers are facing back into the main bar area.

I asked SIMMS to turn on his smaller speakers first. I exited onto the back patio, which is adjacent to the alley behind the building. SIMMS started playing music, while I stood along a wooden fence between the patio and the alley. I could somewhat hear the smaller speakers on the patio.

I then asked SIMMS to turn off the smaller speakers and turn on the bigger speakers. Standing in the same spot SIMMS turned on the speakers and began playing music. The level of the music was noticeably louder, with a lot more bass.

I again spoke to SIMMS and stated the people calling in the calls for service were complaining of the

music and the bass, which appear to be coming from the bigger speakers. I asked him if he could turn down the sound level of the speakers. He stated he could with the speakers controlled with his phone, but the two smaller and 2 bigger speakers that are hooked up to the Juke Box, he could not control the sound level of those speakers. The owner of the Juke Box, would have to come to the bar and physically manipulate the machine to lower the volume of the speakers.

Again, I was listening to the speakers during day time hours with noise from cars and other noises that are present during daytime hours. The speakers were not listened to during the night time hours, where there is less outside noise.

As I was talking to SIMMS I advised him to contact the city for further guidance regarding a decibel meter reading, both at day and night. SIMMS was asking about sound dampening material for the back part of the bar, where the big speakers are located.

SIMMS stated he is working with the people in the neighborhood, that they call him or text him and that he does his best to work with them when there are noise concerns. SIMMS also stated he could move the bigger speakers into the main bar or remove the bigger speakers and replace them with smaller speakers. SIMMS did say if it would solve the complaints, he would get rid of the Juke Box and just have music off of the phone.

I advised him that I would file a license premise report, showing that I did come out to the bar and listen to his speakers, as well as that he is trying to work with his neighbors regarding this matter.
