2. On 10/18/20 officers were dispatched to Clark, 9040 W. Silver Spring Dr., for a Shots Fired. Officers spoke to the caller who stated they heard multiple gun shots coming from the parking lot. Officers also spoke to the employee on scene who stated he also heard the gunshots. 39 casings were recovered and the employee was cooperative and helpful allowing officers to view video surveillance of the incident.

- 3. On 02/28/23 at 5:54a.m., officers were dispatched to a Property Damage at 9040 W. Silver Spring Dr. Officers interviewed the agent who stated he received a call from an employee that watches his business after closing via cameras stating an unknown subject caused damage to the pumps. Officers viewed the video surveillance which depicts a vehicle pull into the lot and a subject damage four pumps with a hammer. The agent was cooperative with the investigation.
- 4. On 03/17/23 at 1:47a.m., officers were dispatched to a Trouble with Subject at 9040 W. Silver Spring Dr. Officers interviewed the caller who had a mental health emergency and requested conveyance to MCMH.
- 5. On 04/28/23 at 3:05p.m., officers were dispatched to an Armed Robbery at the victim's residence. The victim stated the incident occurred at 9040 W. Silver Spring Dr. The victim stated he entered the gas station and was approached by the suspect, who checked the victim's pant pocket and removed his cellphone. The victim further stated the suspect hit him, causing him to fall. Officers interviewed the clerk who stated he observed the suspect hit the victim multiple times. Video surveillance depicted the victim and suspect in a verbal argument then the suspect strikes the victim multiple times causing the victim to fall, however, the victim's cell phone remained in his pocket the entire time and the suspect's hand appear empty. The clerk was cooperative with the investigation providing video surveillance of the incident.

INITIAL INVESTIGATION

This report was submitted by Police Officer Rafael LOPEZ, assigned to District Four, Late Shift, as Squad 4332, along with partner Police Officer Michael SMITH.

On Tuesday, February 28, 2023, at 5:54 a.m., P.O. SMITH and I responded to a Property Damage complaint at 9040 W. Silver Spring Dr. this address is located in the City and County of Milwaukee, Wisconsin.

The above listed location is a Clark Gas Station located on the northeast corner of W. Silver Spring Dr. and N. 91th St. in the City of Milwaukee, with the main entrance facing southbound.

Shoabi I. KIYANI (m/I, 9-2-1991) identified himself as the caller and the owner of the above listed business the Clark Gas Station. KIYANI stated that on Tuesday, February 28, 2023, at approximately 4:34 a.m. he received a call from his "camera man" who told him that he observed on the surveillance cameras someone hitting the gas pumps at his gas station. KIYANI stated to me that the gas station is closed between the hours of 2:00am and 5:00am and that he has a "camera man" watch his business remotely through the surveillance camera system. KIYANI goes on to state that he arrived at the above listed gas station at approximately 5:00am after receiving the call from his "camera guy" and observed the damage to all four gas pumps and he called the police to report the incident.

We reviewed the surveillance camera video of tonight's incident where it depicts a blue Dodge Caravan with no plates pull into the gas station at approximately

3:23am. Few minutes later after the minivan pulls into the gas station a black male, 6'00" tall, 230lbs., wearing a black full ski mask covering his face, red shirt, blue jeans, gray shoes, and black gloves is observed exiting the blue minivan and damage all four gas pumps with a hammer. The suspect then gets back in the blue minivan and drives off in an unknown direction.

KIYANI stated that he does not recognize the suspect depicted on the surveillance video and that he does not suspect anyone of damaging the gas pumps.

KIYANI was unable to give me an approximate dollar value of the damage to the gas pumps and stated to me that he would have to get an estimate done hopefully by today. I told KIYANI I would follow-up with him on 3-1-2023 which I did (please see CAD #230600249) and I was still unable to obtain an estimate from KIYANI.

Officers responded to an Armed Robbery complaint that occurred at the Clark Gas Station located at 9040 W Silver Spring Dr.

Officers spoke with the employee that was working at the time of the incident who identified himself as Olakunle P. OGUNSANYA (B/M, 7/16/1981). OGUNSANYA stated that he observed the victim and suspect enter into the store. OGUNSANYA stated that the suspect struck the victim multiple times and made threats to harm the victim.

OGUNSANYA provided officers with video surveillance of the incident.

OFFICER'S INCIDENT NOTIFICATION SYNOPSIS:

Officers responded to Armed Robbery complaint. Officers met victim at his residence Victim stated that he was robbed at the gas station located at 9040 W Silver Spring Dr.

Victim stated that the suspect was already in the store when he walked in. Victim stated when he entered the store, the suspect checked his pants pocket, removed his cell phone then hit him, causing him to fall down. Victim stated that the suspect then entered his vehicle which was described as a maroon Nissan with no tint and left the location.

Officers went to the gas station where this incident occurred to watch video. Officers observed the suspect entered the gas station at 3:05pm and the victim entered the store seconds after. Officers observed the victim and the suspect engage in a verbal altercation. The suspect then touches the victim's pocket then punched him once in the face causing the victim to fall. The suspect continues to yell and point his finger in the victim's face. The suspects hands appear to be empty. Throughout the altercation that continues to go on, the suspect continues to strike the victim twice more in the face.

The victim's cellphone appears to be in his pocket through the duration of this incident.

The victim then attempts to hand the suspect money. The suspect left the store in a vehicle.

Officers spoke to gas station clerk that was there at the time of the incident who stated he knew the victim and that he is cognitively delayed, so he always tries to help him when he comes into the store. The clerk stated the suspect made comments to the victim that he was going to kill him if the victim told anyone what happened.



Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
